A BILL ENTITLED

1 AN ACT concerning

2 **State Board of Pharmacy – Licensure Requirements for Pharmacists – Proof of**
3 **Proficiency in English**

4 FOR the purpose of providing that, for applicants for a license to practice pharmacy,
5 graduation from certain schools is acceptable proof of proficiency in the oral
6 communication of the English language under a certain provision of law; and
7 generally relating to licensure requirements for pharmacists.

8 BY repealing and reenacting, with amendments,

9 Article – Health Occupations

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

14 That the Laws of Maryland read as follows:

15 **Article – Health Occupations**

16 12–302.

17 (g) (1) **[The] EXCEPT AS OTHERWISE PROVIDED IN THIS SUBSECTION,**
18 **THE** Board shall require, as part of its examination or licensing procedures, an applicant
19 for a license to practice pharmacy to demonstrate an oral competency in the English
20 language by passing a Board approved standardized test of oral competency.

21 (2) The Board shall adopt regulations that establish a procedure for testing
22 an individual who because of the individual’s speech or hearing impairment is unable to
23 complete satisfactorily a Board approved standardized test of oral competency.

1 (3) If any disciplinary charge or action that relates to a problem with the
2 oral communication of the English language is brought against a licensee under this title,
3 the Board shall require the licensee to pass a Board approved standardized test of oral
4 competency.

5 (4) The Board may not require an applicant for a license to practice
6 pharmacy, who was previously licensed in another state to practice pharmacy, to
7 demonstrate an oral competency in the English language, if the other state's examination
8 and licensing procedures at the time the applicant was licensed in the other state included
9 an oral competency component similar to the oral competency component in this State's
10 examination and licensing procedures.

11 **(5) GRADUATION FROM A RECOGNIZED ENGLISH-SPEAKING**
12 **UNDERGRADUATE SCHOOL OR HIGH SCHOOL AFTER AT LEAST 3 YEARS OF**
13 **ENROLLMENT OR FROM A RECOGNIZED ENGLISH-SPEAKING PROFESSIONAL**
14 **SCHOOL ACCREDITED BY THE ACCREDITATION COUNCIL FOR PHARMACY**
15 **EDUCATION IS ACCEPTABLE AS PROOF OF PROFICIENCY IN THE ORAL**
16 **COMMUNICATION OF THE ENGLISH LANGUAGE UNDER THIS SUBSECTION.**

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
18 October 1, 2016.
