CHAPTER _____

1 AN ACT concerning

Department of Veterans Affairs – Charlotte Hall Veterans Home Fund – Establishment

FOR the purpose of establishing the Charlotte Hall Veterans Home Fund as a special, 4 nonlapsing fund; specifying the purpose of the Fund; requiring the Secretary of 5 6 Veterans Affairs to administer the Fund; prohibiting, except under certain 7 circumstances, any unspent portions of the Fund from being transferred to or 8 reverting to the General Fund of the State; requiring the State Treasurer to hold the 9 Fund and the Comptroller to account for the Fund; specifying the contents of the 10 Fund; specifying the purposes for which the Fund may be used; providing for the investment of money in and expenditures from the Fund; providing that money 11 12 expended from the Fund for the Charlotte Hall Veterans Home is supplemental to, and is not intended to take the place of, funding that would otherwise be 13 appropriated; requiring the Office of Legislative Audits to audit the accounts and 14 15 transactions of the Fund as provided in a certain provision of law; defining certain 16 terms; and generally relating to the Charlotte Hall Veterans Home Fund.
