CHAPTER
AN ACT concerning
Gaming Payouts - Donation of Coins <u>Pilot Program - Donation of Coins From</u> <u>Gaming Payouts</u> - Maryland Veterans Trust Fund
FOR the purpose of requiring the State Lottery and Gaming Control Commission to adopt regulations requiring authorizing certain requiring a video lottery facility licensees licensee to adopt certain procedures for to offer certain players the opportunity to donate coins to the Maryland Veterans Trust Fund under certain circumstances; requiring the Commission to adopt regulations requiring authorizing certain licensees requiring a licensee to attach certain boxes near exits in certain a video lottery facilities facility for certain purposes; specifying the source of certain revenues for the Fund; requiring the Commission to report to certain committees of the General Assembly on or before a certain date; and generally relating to gaming payouts and revenues for the Maryland Veterans Trust Fund
