## A BILL ENTITLED

1 AN ACT concerning

Study Group to Investigate Discriminatory Practices Against Minority
 Franchisees

4 FOR the purpose of establishing the Study Group to Investigate Discriminatory Practices Against Minority Franchisees; providing for the composition, chair, and staffing of  $\mathbf{5}$ 6 the Study Group; prohibiting a member of the Study Group from receiving certain 7 compensation, but authorizing the reimbursement of certain expenses; requiring the 8 Study Group to study and make recommendations regarding certain matters; 9 requiring the Study Group to report its findings and recommendations to the Governor and the General Assembly on or before a certain date; providing for the 10 11 termination of this Act; and generally relating to the Study Group to Investigate 12Discriminatory Practices Against Minority Franchisees.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 14 That:

(a) In this section, "minority" means an individual of African American, Hispanic,
Native American, or Asian descent.

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 2 1, 2016. It shall remain effective for a period of 1 year and 1 month and, at the end of June 3 30, 2017, with no further action required by the General Assembly, this Act shall be 4 abrogated and of no further force and effect.
