BY repealing and reenacting, without amendments, Article - Family Law Section 12–201(a) and 12–204(h), (l), and (m) Annotated Code of Maryland (2012 Replacement Volume and 2015 Supplement) BY repealing and reenacting, with amendments, Article – Family Law Section 12–201(g) Annotated Code of Maryland (2012 Replacement Volume and 2015 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article – Family Law 12 - 201.

- 1 (a) In this subtitle the following words have the meanings indicated.
- 2 (g) (1) "Extraordinary medical expenses" means uninsured [expenses over 3 \$100 for a single illness or condition] COSTS FOR MEDICAL TREATMENT IN EXCESS OF \$250 IN ANY CALENDAR YEAR.
- 5 (2) "Extraordinary medical expenses" includes uninsured, reasonable, and 6 necessary costs for orthodontia, dental treatment, **VISION CARE**, asthma treatment, 7 physical therapy, treatment for any chronic health problem, and professional counseling or 8 psychiatric therapy for diagnosed mental disorders.

- 10 (h) (1) Any actual cost of providing health insurance coverage for a child for whom the parents are jointly and severally responsible shall be added to the basic child support obligation and shall be divided by the parents in proportion to their adjusted actual incomes.
- 14 (2) Any extraordinary medical expenses incurred on behalf of a child shall 15 be added to the basic child support obligation and shall be divided between the parents in 16 proportion to their adjusted actual incomes.
- (l) (1) Except in cases of shared physical custody, each parent's child support obligation shall be determined by adding each parent's respective share of the basic child support obligation, work-related child care expenses, health insurance expenses, extraordinary medical expenses, and additional expenses under subsection (i) of this section.
- 22 (2) The obligee shall be presumed to spend that parent's total child support obligation directly on the child or children.
- 24 (3) The obligor shall owe that parent's total child support obligation as 25 child support to the obligee minus any ordered payments included in the calculations made 26 directly by the obligor on behalf of the child or children for work—related child care 27 expenses, health insurance expenses, extraordinary medical expenses, or additional 28 expenses under subsection (i) of this section.
- 29 (m) (1) In cases of shared physical custody, the adjusted basic child support 30 obligation shall first be divided between the parents in proportion to their respective 31 adjusted actual incomes.
- 32 (2) Each parent's share of the adjusted basic child support obligation shall 33 then be multiplied by the percentage of time the child or children spend with the other 34 parent to determine the theoretical basic child support obligation owed to the other parent.
