BY repealing and reenacting, with amendments, Article – Transportation Section 22–412.3(a) and (c) Annotated Code of Maryland (2012 Replacement Volume and 2015 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Transportation 22-412.3.(a) (1) In this section the following words have the meanings indicated. (2)(i) "Motor vehicle" means a vehicle that is:

6	(ii) "Motor vehicle" does not include a Class L (historic) vehicle.
7 8	(3) ["Outboard front seat" means a front seat position that is adjacent to a door of a motor vehicle.
9 10	(4)] (i) "Seat belt" means a restraining device described under § 22–412 of this subtitle.
11	(ii) "Seat belt" includes a combination seat belt-shoulder harness.
12 13	(c) (1) The provisions of this subsection apply to a person who is at least 16 years old.
14 15	(2) Unless a person is restrained by a seat belt, the person may not be a passenger in [an outboard front seat of] a motor vehicle.
