### A BILL ENTITLED

1 AN ACT concerning

# 2 Creation of a State Debt – Baltimore City – Maryland State Boychoir ADA 3 Improvements

FOR the purpose of authorizing the creation of a State Debt not to exceed \$325,000, the
proceeds to be used as a grant to the Board of Directors of The Maryland State
Boychoir, Inc. for certain development or improvement purposes; providing for
disbursement of the loan proceeds, subject to a requirement that the grantee provide
and expend a matching fund; establishing a deadline for the encumbrance or
expenditure of the loan proceeds; and providing generally for the issuance and sale
of bonds evidencing the loan.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 That:

13The Board of Public Works may borrow money and incur indebtedness on (1)behalf of the State of Maryland through a State loan to be known as the Baltimore 14 15City – Maryland State Boychoir ADA Improvements Loan of 2016 in a total principal amount equal to the lesser of (i) \$325,000 or (ii) the amount of the matching fund provided 16in accordance with Section 1(5) below. This loan shall be evidenced by the issuance, sale, 17and delivery of State general obligation bonds authorized by a resolution of the Board of 18Public Works and issued, sold, and delivered in accordance with §§ 8-117 through 8-124 1920and 8-131.2 of the State Finance and Procurement Article.

(2) The bonds to evidence this loan or installments of this loan may be sold as a
single issue or may be consolidated and sold as part of a single issue of bonds under §
8–122 of the State Finance and Procurement Article.

(3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer and first shall be applied to the payment of the expenses of issuing, selling, and delivering the bonds, unless funds for this purpose are otherwise provided, and then shall be credited on the books of the Comptroller and expended, on approval by the Board of Public Works, for

1 the following public purposes, including any applicable architects' and engineers' fees: as a  $\mathbf{2}$ grant to the Board of Directors of The Maryland State Boychoir, ADA Improvements, Inc. 3 (referred to hereafter in this Act as "the grantee") for the acquisition, planning, design, 4 construction, repair, renovation, reconstruction, and capital equipping of ADA improvements at the Maryland State Boychoir facility, located in Baltimore City.

6 (4)An annual State tax is imposed on all assessable property in the State in rate 7and amount sufficient to pay the principal of and interest on the bonds, as and when due 8 and until paid in full. The principal shall be discharged within 15 years after the date of 9 issuance of the bonds.

10 (5)Prior to the payment of any funds under the provisions of this Act for the 11 purposes set forth in Section 1(3) above, the grantee shall provide and expend a matching 12fund. No part of the grantee's matching fund may be provided, either directly or indirectly, 13from funds of the State, whether appropriated or unappropriated. No part of the fund may 14consist of real property or funds expended prior to the effective date of this Act. The fund 15may consist of in kind contributions. In case of any dispute as to the amount of the matching 16fund or what money or assets may qualify as matching funds, the Board of Public Works 17shall determine the matter and the Board's decision is final. The grantee has until June 1, 18 2018, to present evidence satisfactory to the Board of Public Works that a matching fund will be provided. If satisfactory evidence is presented, the Board shall certify this fact and 1920the amount of the matching fund to the State Treasurer, and the proceeds of the loan equal 21to the amount of the matching fund shall be expended for the purposes provided in this Act. 22Any amount of the loan in excess of the amount of the matching fund certified by the Board 23of Public Works shall be canceled and be of no further effect.

24(6)The proceeds of the loan must be expended or encumbered by the Board of 25Public Works for the purposes provided in this Act no later than June 1, 2023. If any funds 26authorized by this Act remain unexpended or unencumbered after June 1, 2023, the 27amount of the unencumbered or unexpended authorization shall be canceled and be of no 28further effect. If bonds have been issued for the loan, the amount of unexpended or 29unencumbered bond proceeds shall be disposed of as provided in § 8-129 of the State 30 Finance and Procurement Article.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 31 321, 2016.
