15	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16	That the Laws of Maryland read as follows:
17	Article - State Personnel and Pensions

19	(a) This section does not apply to a DISABILITY retiree [who is]:
20	(1) WHO IS a retiree of:
21	(i) the State Police Retirement System;
22	(ii) the Law Enforcement Officers' Pension System;

2 3 4	(iv) the Employees' Retirement System or the Employees' Pension System, if at the time of retirement the retiree was a law enforcement officer for a participating employer under § 26–201(a) of this article; and
5 6 7	(2) WHO IS reemployed by a participating employer in any position other than a probationary status law enforcement officer, a law enforcement officer, or chief, as defined in § 3–101 of the Public Safety Article; OR

10 11	(b) The Board of Trustees shall reduce the pension of a retiree on ordinary disability if:
12	(1) the retiree is under normal retirement age;
13 14 15	(2) the medical board certifies in a report to the Board of Trustees that the retiree is employed by a participating employer at an annual compensation that is greater than the difference between:
16	(i) the retiree's retirement allowance at retirement; and
17	(ii) the retiree's average final compensation plus \$5,000;
18	(3) the Board of Trustees agrees with the medical board's report; and
19 20	(4) the retiree's allowance has not been temporarily suspended as provided in \S 29–115 of this subtitle.
21 22	(c) The Board of Trustees shall reduce the pension of a retiree who has been receiving an ordinary disability retirement allowance for:
23 24	(1) less than 10 years, by \$1 for every \$2 that the retiree's current compensation exceeds the limit under subsection (b) of this section; or
25 26	(2) at least 10 years, by \$1 for every \$5 that the retiree's current compensation exceeds the limit under subsection (b) of this section.
27 28	(d) The pension to be reduced under this section is the pension at retirement without any cost-of-living adjustment.
29	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
