AND BE IT FURTHER ENACTED, That the provisions of this Act relating to a normal service retirement under § 25–401 of the State Personnel and Pensions Article shall be construed to apply only prospectively to an individual who retires on or after the effective date of this Act and may not be applied or interpreted to have any effect on or application to an individual who retires before the effective date of this Act.
