A BILL ENTITLED

1 AN ACT concerning

2 **Human Services – Interagency Council on Homelessness – Membership**

3 FOR the purpose of altering the composition of the Interagency Council on Homelessness;
4 increasing the number of representatives from diverse geographical regions of the
5 State engaged in homeless advocacy; making a stylistic change; and generally
6 relating to the Interagency Council on Homelessness.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

18 That the Laws of Maryland read as follows:

- 1 (1) the Secretary of Aging, or the Secretary's designee;
- 2 (2) the Secretary of Budget and Management, or the Secretary's designee;
- 3 (3) the Secretary of Health and Mental Hygiene, or the Secretary's
4 designee;
- 5 (4) the Secretary of Housing and Community Development, or the
6 Secretary's designee;
- 7 (5) the Secretary, or the Secretary's designee;
- 8 (6) the Secretary of Labor, Licensing, and Regulation, or the Secretary's
9 designee;
- 10 (7) the Secretary of Public Safety and Correctional Services, or the
11 Secretary's designee;
- 12 (8) the State Superintendent of Schools, or the State Superintendent's
13 designee;
- 14 (9) the Secretary of Transportation, or the Secretary's designee;
- 15 (10) the Secretary of Veterans Affairs, or the Secretary's designee;
- 16 (11) the Secretary of Juvenile Services, or the Secretary's designee; and
- 17 (12) the following members, appointed by the Governor:
- 18 (i) one representative of the Governor's Office for Children;
- 19 (ii) three representatives of local Continuums of Care;
- 20 (iii) ~~six~~ **NINE** representatives from diverse geographical regions of
21 the State engaged in homeless advocacy with a focus on housing, employment, and access
22 to ~~healthcare~~ **HEALTH CARE**; and
- 23 (iv) one community representative who has personally experienced
24 homelessness.
- 25 (b) The Governor may remove a member for incompetence or misconduct.
- 26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
27 1, 2016.
