1 AN ACT concerning

2 Criminal Procedure – Expungement – Denial of Petition Without Hearing

- 3 FOR the purpose of altering a certain provision of law to authorize, rather than require, a 4 court to hold a hearing on a certain petition for expungement if the State's Attorney $\mathbf{5}$ files a timely objection to the petition; authorizing a court to deny a certain petition 6 for expungement without a hearing if the court finds that the petition is barred as a 7 matter of law; authorizing a certain petitioner to request a hearing within a certain 8 amount of time under certain circumstances; requiring the court to hold a hearing 9 under certain circumstances; making conforming changes; and generally relating to 10 expungement of court and police records.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 That the Laws of Maryland read as follows:

5 (a) A person who has been charged with the commission of a crime, including a 6 violation of the Transportation Article for which a term of imprisonment may be imposed, 7 or who has been charged with a civil offense or infraction, except a juvenile offense, as a 8 substitute for a criminal charge may file a petition listing relevant facts for expungement 9 of a police record, court record, or other record maintained by the State or a political 10 subdivision of the State if:

the person is acquitted;

12 (2) the charge is otherwise dismissed;

(3) a probation before judgment is entered, unless the person is charged
with a violation of § 21–902 of the Transportation Article or Title 2, Subtitle 5 or § 3–211
of the Criminal Law Article;

16 (4) a nolle prosequi or nolle prosequi with the requirement of drug or 17 alcohol treatment is entered;

18 (5) the court indefinitely postpones trial of a criminal charge by marking 19 the criminal charge "stet" or stet with the requirement of drug or alcohol abuse treatment 20 on the docket;

21 (6) the case is compromised under \S 3–207 of the Criminal Law Article;

(7) the charge was transferred to the juvenile court under § 4–202 of this
article;

(i) is convicted of only one criminal act, and that act is not a crimeof violence; and

(ii) is granted a full and unconditional pardon by the Governor;

under any State or local law that prohibits:

1 (II) IF THE COURT DENIES A PETITION WITHOUT A HEARING 2 UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH, THE PETITIONER MAY REQUEST A 3 HEARING WITHIN **30** DAYS.

4 (III) IF A PETITIONER REQUESTS A HEARING UNDER 5 SUBPARAGRAPH (II) OF THIS PARAGRAPH, THE COURT SHALL HOLD A HEARING.

(4) The person is not entitled to expungement if:

7 (i) the petition is based on the entry of probation before judgment, 8 except a probation before judgment for a crime where the act on which the conviction is 9 based is no longer a crime, and the person within 3 years of the entry of the probation before 10 judgment has been convicted of a crime other than a minor traffic violation or a crime where 11 the act on which the conviction is based is no longer a crime; or

(ii) the person is a defendant in a pending criminal proceeding.

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 14 October 1, 2016.
