A BILL ENTITLED

1 AN ACT concerning

Department of Economic Competitiveness and Commerce – Expansion of International Market Presence – Feasibility Study

FOR the purpose of requiring the Department of Economic Competitiveness and Commerce 4 $\mathbf{5}$ to conduct or hire a consultant to conduct a certain feasibility study relating to the 6 expansion of the international market presence of businesses in the State; requiring 7 the Department to report the findings of the feasibility study to the Governor and 8 the General Assembly within a certain time period under certain circumstances; 9 making this Act subject to a certain contingency; providing for the termination of this Act under certain circumstances; and generally relating to the Department of 1011 Economic Competitiveness and Commerce.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,13 That:

14 (a) The Department of Economic Competitiveness and Commerce shall conduct 15 or hire a consultant to conduct an assessment of the feasibility of expanding the 16 international market presence of businesses in the State.

The feasibility study shall include:

18 (1) an analysis of the international market presence of businesses in the 19 State, including an overview of current export sales, foreign trade offices, and foreign trade 20 shows and targeted missions;

an analysis of the international market presence of other states; and

(3) an assessment of the feasibility of expanding the international market
presence of businesses in the State by:

 $\mathbf{2}$ increasing exports to international markets of goods and services (i) produced in the State: (ii) raising awareness of existing export promotion programs;

(iii) facilitating greater access and usage of the State's ExportMD grant and FlexEx programs;

(v) expanding the current network of foreign trade offices.

9 SECTION 2. AND BE IT FURTHER ENACTED, That, within 6 months after receiving funding under Section 3 of this Act, the Department shall report on the findings 10 of the feasibility study to the Governor and, in accordance with § 2-1246 of the State 11 12Government Article, the General Assembly.

13SECTION 3. AND BE IT FURTHER ENACTED, That this Act is contingent on the receipt of federal funding or funding from any other source to finance the feasibility study 14required under Section 1 of this Act. The Department of Economic Competitiveness and 15Commerce shall notify the Department of Legislative Services within 15 days after the 16funding is received. If notice of the receipt of funding is not received by the Department of 1718 Legislative Services on or before June 30, 2019, this Act shall be null and void without the 19necessity of further action by the General Assembly.

20SECTION 4. AND BE IT FURTHER ENACTED, That, subject to the provisions of 21Section 3 of this Act, this Act shall take effect July 1, 2016.
