CHAPTER _____

1 AN ACT concerning

2 **Health Occupations – Dental Hygienists – Local Anesthesia**

3 FOR the purpose of altering the circumstances under which a dental hygienist may
4 administer local anesthesia by infiltration or inferior nerve block; and generally
5 relating to the administration of local anesthesia by dental hygienists.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Health Occupations**

19 4–101.

1 (a) In this title the following words have the meanings indicated.

2 (k) “Practice dental hygiene” means to:

3 (1) Perform a preliminary dental examination;

4 (2) Perform a complete prophylaxis, including the removal of any deposit,
5 accretion, or stain from the surface of a tooth or a restoration;

6 (3) Polish a tooth or a restoration;

7 (4) Chart cavities, restorations, missing teeth, periodontal conditions, and
8 other features observed during preliminary examination, prophylaxis, or polishing;

9 (5) Apply a medicinal agent to a tooth for a prophylactic purpose;

10 (6) Take a dental X ray;

11 (7) Perform a manual curettage in conjunction with scaling and root
12 planning;

13 (8) Administer local anesthesia in accordance with § 4–206.1 or § 4–206.3
14 of this title;

15 (9) Monitor, in accordance with § 4–206.2 of this title, a patient to whom
16 nitrous oxide is administered; or

17 (10) Perform any other intraoral function that the Board authorizes by a
18 rule or regulation adopted under § 4–206 of this title.

19 (l) “Practice dentistry” means to:

20 (1) Be a manager, a proprietor, or a conductor of or an operator in any place
21 in which a dental service or dental operation is performed intraorally;

22 (2) Perform or attempt to perform any intraoral dental service or intraoral
23 dental operation;

24 (3) Diagnose, treat, or attempt to diagnose or treat any disease, injury,
25 malocclusion, or malposition of a tooth, gum, or jaw, or structures associated with a tooth,
26 gum, or jaw if the service, operation, or procedure is included in the curricula of an
27 accredited dental school or in an approved dental residency program of an accredited
28 hospital or teaching institution;

29 (4) Perform or offer to perform dental laboratory work;

30 (5) Place or adjust a dental appliance in a human mouth; or

1 (6) Administer anesthesia for the purposes of dentistry and not as a
2 medical specialty.

4 (a) Subject to the requirements of subsections (b) and (c) of this section, a dental
5 hygienist may administer local anesthesia by infiltration [for the purpose of anesthetizing
6 soft tissue] to facilitate the [performance] **PRACTICE** of dental hygiene [procedures] **BY A**
7 **DENTAL HYGIENIST OR THE PRACTICE OF DENTISTRY BY A DENTIST**, but not as a
8 medical specialty, provided the administration of local anesthesia is under the supervision
9 of a dentist who:

10 (1) Is physically present on the premises; and

11 (2) Prescribes the administration of local anesthesia by the dental
12 hygienist.

13 (b) Before a dental hygienist may administer local anesthesia under subsection
14 (a) of this section, the dental hygienist shall successfully complete the following:

15 (1) Any educational requirements established by the Board; and

16 (2) A written and clinical examination as required by the Board.

17 (c) A dental hygienist shall obtain the educational requirements established by
18 the Board under subsection (b)(1) of this section from an accredited dental hygiene
19 program.

21 (a) Subject to the requirements of subsection (b) of this section, a dental hygienist
22 may administer local anesthesia by inferior alveolar nerve block [for the purpose of
23 anesthetizing soft tissue] to facilitate the [performance] **PRACTICE** of dental hygiene
24 [procedures] **BY A DENTAL HYGIENIST OR THE PRACTICE OF DENTISTRY BY A**
25 **DENTIST**, but not as a medical specialty, provided the administration of the local
26 anesthesia is under the supervision of a dentist who:

27 (1) Is physically present on the premises; and

28 (2) Prescribes the administration of local anesthesia by the dental
29 hygienist.

30 (b) (1) Before a dental hygienist may administer local anesthesia under
31 subsection (a) of this section, the dental hygienist shall successfully complete the following:

1 (i) Any educational requirements established by the Board; and

2 (ii) A written and clinical examination as required by the Board.

3 (2) A dental hygienist shall obtain the education required under paragraph
4 (1) of this subsection from an accredited dental hygiene program.

5 (3) A dental hygienist who successfully completed the education
6 requirements and examination required under paragraph (1) of this subsection before
7 October 1, 2011, shall take and successfully complete a refresher course and a clinical
8 examination from an accredited dental hygiene program.

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
10 October 1, 2016.
