## Education - Maryland Seal of Biliteracy Act - Establishment

3 FOR the purpose of establishing the Maryland Seal of Biliteracy Program; providing for the 4 purpose of the Program; providing that participation in the Program by a local school 5 system is voluntary; providing that, beginning with a certain graduating class, 6 certain students shall receive a certain seal under certain circumstances; requiring 7 the State Board of Education to establish certain criteria and requirements by a 8 certain date; requiring the State Board to provide certain information regarding the 9 Program to certain local school systems by a certain date; requiring certain local 10 school systems to maintain certain records; requiring certain local school systems to 11 affix a certain seal to certain academic documents under certain circumstances; 12 requiring the State Board to adopt certain regulations; defining certain terms; and 13 generally relating to the Maryland Seal of Biliteracy Program.

- 6 (G) A LOCAL SCHOOL SYSTEM PARTICIPATING IN THE PROGRAM SHALL:
- 7 (1) MAINTAIN RECORDS NECESSARY FOR DETERMINING A STUDENT'S
- 8 ELIGIBILITY FOR A SEAL OF BILITERACY; AND
- 9 (2) AFFIX A SEAL OF BILITERACY TO THE DIPLOMA OR TRANSCRIPT
- 10 OF EVERY ELIGIBLE STUDENT MEETING THE CRITERIA AND REQUIREMENTS
