3 FOR the purpose of altering the beginning hour of sale for certain alcoholic beverages  
4 licenses issued in Carroll County; and generally relating to alcoholic beverages in  
5 Carroll County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
19 That the Laws of Maryland read as follows:

4 (a) A holder of a Class A beer and wine license may sell or provide beer and wine  
5 on Monday through Sunday from 8 a.m. to 11 p.m.

6 (b) (1) A holder of a 6-day ~~or 7-day~~ Class B beer and wine license may sell or  
7 provide beer and wine for on-premises consumption[:

8 (i)] on Monday through Saturday from 8 a.m. to 1 a.m. the following  
9 day[; and

10 (ii) on Sunday from 11 a.m. to 1 a.m. the following day].

11 (2) A holder of a 7-day Class B beer and wine license may sell **OR PROVIDE**  
12 beer and wine for ~~ON-OR-off-premises~~ **ON-PREMISES** consumption[:

13 (i)] on Monday through [Saturday] **SUNDAY** from 8 a.m. to ~~11 p.m.~~  
14 **1 A.M.** the following day[; and

15 (ii) on Sunday from 11 a.m. to 11 p.m].

16 **(3) A HOLDER OF A 7-DAY CLASS B BEER AND WINE LICENSE MAY**  
17 **SELL BEER AND WINE FOR OFF-PREMISES CONSUMPTION ON MONDAY THROUGH**  
18 **SUNDAY FROM 8 A.M. TO 11 P.M.**

19 (c) A holder of a Class C beer and wine license may sell or provide beer and wine  
20 on Monday through Saturday from 8 a.m. to 1 a.m. the following day.

21 (d) (1) A holder of a 6-day or 7-day Class D beer and wine license may sell or  
22 provide beer and wine on Monday through Saturday from 6 a.m. to midnight.

23 (2) A holder of a 7-day Class D beer and wine license may sell or provide  
24 beer and wine on Sunday from [11 a.m.] **8 A.M.** to 11 p.m.

25 16-2005.

26 (a) A holder of a Class A beer, wine, and liquor license may sell or provide beer,  
27 wine, and liquor on Monday through Sunday from 8 a.m. to 11 p.m.

28 (b) A holder of a Class B beer, wine, and liquor license may sell or provide beer,  
29 wine, and liquor[:

1 (1) on Monday through [Saturday] SUNDAY from 8 a.m. to 1 a.m. the  
2 following day[; and

3 (2) on Sunday from 11 a.m. to 1 a.m. the following day].

4 (c) A holder of a Class C beer, wine, and liquor license may sell or provide beer,  
5 wine, and liquor[:

6 (1) on Monday through [Saturday] SUNDAY from 8 a.m. to 1 a.m. the  
7 following day[; and

8 (2) on Sunday from 11 a.m. to 1 a.m. the following day].

9 (d) Reserved.

10 (e) A holder of a Class H beer, wine, and liquor license may sell or provide beer,  
11 wine, and liquor[:

12 (1) on Monday through [Saturday] SUNDAY from 8 a.m. to 1 a.m. the  
13 following day[; and

14 (2) on Sunday from 11 a.m. to 1 a.m. the following day].

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
16 1, 2016.
