- 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 14 That the Laws of Maryland read as follows:

- 17 (a) (1) In addition to any other penalty or fine provided in this title, a person who holds a license to catch oysters under § 4–701 of this title and receives a citation for an offense listed under paragraph (2) of this subsection may have the license revoked in accordance with this section.

- 1 (i) Taking oysters located more than 200 feet within a closed or 2 prohibited area: 3 Taking oysters with [gear that is prohibited in that area] A (ii) POWER DREDGE IN AN AREA RESERVED FOR ANOTHER TYPE OF GEAR; 4 5 Taking ovsters outside of a time restriction for the harvest of 6 oysters by more than 1 hour; 7 (iv) Taking oysters during closed seasons; and 8 Taking oysters from a leased area by a person other than the (v) 9 leaseholder or the leaseholder's designee. 10 (b) Within 60 days after a person who holds a license to catch oysters under 11 § 4–701 of this title receives a citation for an offense listed under subsection (a) of this 12 section, the Department shall hold a hearing on the matter in accordance with the 13 Administrative Procedure Act under Title 10, Subtitle 2 of the State Government Article. 14 After a hearing is conducted under paragraph (1) of this subsection, if 15 the presiding officer finds or concludes that the person knowingly has committed an offense 16 listed under subsection (a)(2) of this section, the Department shall revoke the person's 17 license to catch oysters. 18 (c) A person who is aggrieved by the final decision of the Department may obtain judicial review of the decision in accordance with the Administrative Procedure Act under 19 20 Title 10, Subtitle 2 of the State Government Article. 21A person whose license has been revoked in accordance with this section may 22not engage or work in the fishery for which the license was revoked whether or not it 23requires the use of another license.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2016.
