- 3 FOR the purpose of altering the eligibility provisions of the Optional Retirement Program to include individuals in certain position categories designated by certain governing 4 $\mathbf{5}$ boards of institutions of higher education or the Secretary of Higher Education; 6 authorizing an individual who was a participant in the Optional Retirement 7 Program as of a certain date to continue to participate in the Program under certain 8 circumstances; conforming certain terminology to current institutional policies 9 regarding employment categories; and generally relating to eligibility for the **Optional Retirement Program.** 10

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
