BY repealing and reenacting, without amendments, Article – Alcoholic Beverages Section 9–101(a) and (b), 9–102, and 9–2005 Annotated Code of Maryland (As enacted by Chapter ____ (S.B. ____)(6lr1406) of the Acts of the General Assembly of 2016) BY repealing and reenacting, with amendments, Article – Alcoholic Beverages Section 9–2002(d), 9–2003(d), and 9–2004(b) and (d) Annotated Code of Maryland (As enacted by Chapter ____ (S.B. ____)(6lr1406) of the Acts of the General Assembly of 2016) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

AND BE IT FURTHER ENACTED, That before this Act becomes effective it shall first be submitted to a referendum of the qualified voters of Allegany County at the general election to be held in November of 2016. The County governing body and the Allegany County Board of Elections shall do those things necessary and proper to provide for and hold the referendum required by this section. If a majority of the votes cast on the question are "For the referred law" the provisions of this Act shall become effective on the 30th day following the official canvass of votes for the referendum, but if a majority of the votes cast on the question are "Against the referred law" the provisions of this Act are of no effect and null and void. SECTION 3. AND BE IT FURTHER ENACTED, That, subject to the provisions of Section 2 of this Act and for the sole purpose of providing for the referendum required by Section 2 of this Act, this Act shall take effect July 1, 2016.
