Commission on Innovation and Excellence in Education

FOR the purpose of establishing the Commission on Innovation and Excellence in Education; providing for the composition, chair, and staffing of the Commission; requiring certain appointments to be made to ensure diversity within the Commission; prohibiting a member of the Commission from receiving certain compensation, but authorizing the reimbursement of certain expenses; requiring the Commission to review the findings and recommendations of a certain study, review certain education finance formulas, review certain accountability measures and review certain other matters; requiring the Commission to make certain recommendations on certain matters; requiring the Commission to make a preliminary and a final report of its findings and recommendations to the Governor and the General Assembly on or before certain dates; requiring certain appointments to the Commission to be made within a certain period of time; requiring a certain master plan to include certain information during certain calendar years; requiring the State Department of Education to convene a certain group of stakeholders to review certain requirements of a certain master plan and the federal Every Student Succeeds Act; requiring the Department to make a certain report on or before a certain date; providing for the termination of this Act; and generally relating to the Commission on Innovation and Excellence in Education.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

- (a) There is a Commission on Innovation and Excellence in Education. 1 (1) 2 (2)The Commission shall review the findings of the Study on Adequacy of 3 Funding for Education in the State of Maryland that is to be completed on or before 4 December 1, 2016, and provide recommendations on preparing students in the State to meet the challenges of a changing global economy, to meet the State's workforce needs, to 5 be prepared for postsecondary education and the workforce, and to be successful citizens in 6 7 the 21st century. 8 (b) The Commission consists of the following members: 9 two members of the Senate Education, Health, and Environmental Affairs Committee, appointed by the President of the Senate: 10 11 two members of the Senate Budget and Taxation Committee, appointed 12 by the President of the Senate; 13 two members of the House Committee on Ways and Means, appointed (3)by the Speaker of the House; 14 15 **(4)** two members of the House Appropriations Committee, appointed by the Speaker of the House; 16 the State Superintendent of Schools; 17 (5)18 the Secretary of Budget and Management; (6) 19 the Chancellor of the University System of Maryland; (7)20 one representative of the State Board of Education, appointed by the 21President of the Board: 22 one representative of the Maryland State Education Association, (9)23 appointed by the Executive Director of the Association: 24one representative of the Baltimore Teachers Union, appointed by the (10)25President of the Union; 26 one representative from a county board of education, appointed by the (11)27 Maryland Association of Boards of Education; 28 one local school superintendent, appointed by the Public School 29Superintendents Association of Maryland;

17 18 19	(2) If by August 1, 2016, the Governor, the President of the Senate, and the Speaker of the House do not jointly appoint a chair, the President of the Senate and the Speaker of the House shall jointly appoint the chair of the Commission.
20 21	(e) The Department of Legislative Services, in consultation with the State Department of Education, shall provide staff for the Commission.
