- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND. 16

| 4 5 | (a) Subject to subsection (c) of this section, the Secretary shall issue a permit within a reasonable time to a person who the Secretary finds: |

| 7 8 | (2) (i) has not been convicted of a felony or of a misdemeanor for which a sentence of imprisonment for more than 1 year has been imposed; or |
| 9 10 | (ii) if convicted of a crime described in item (i) of this item, has been pardoned or has been granted relief under 18 U.S.C. \S 925(c); |
| 11 12 | (3) has not been convicted of a crime involving the possession, use, or distribution of a controlled dangerous substance; |
| 13 14 15 | (4) is not presently an alcoholic, addict, or habitual user of a controlled dangerous substance unless the habitual use of the controlled dangerous substance is under legitimate medical direction; |
| 16 17 18 | (5) except as provided in subsection (b) of this section, has successfully completed prior to application and each renewal, a firearms training course approved by the Secretary that includes: |
| 19 20 | (i) 1 . for an initial application, a minimum of 16 hours of instruction by a qualified handgun instructor; or |
| 21 22 | 2. for a renewal application, 8 hours of instruction by a qualified handgun instructor; |

| 25 | 2. home firearm safety; and |

- 4 (ii) has good and substantial reason to wear, carry, or transport a bandgun, such as a finding that the permit is necessary as a reasonable precaution against apprehended danger; AND
- 7 (7) IS NOT LISTED ON THE TERRORIST WATCHLIST MAINTAINED BY 8 THE TERRORIST SCREENING CENTER OF THE FEDERAL BUREAU OF 9 INVESTIGATION.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 11 October 1, 2016.
