Article - State Finance and Procurement 1 2 3-207.3 (a) In this section the following words have the meanings indicated. (1) "Foster youth" means an individual who: 4 (2) is in out-of-home care under the responsibility of the State; or 5 (i) 6 (ii) 1. is an adult under the age of 26 years; and 7 2. was in out-of-home care under the responsibility of the 8 State on the individual's 18th birthday. 9 "Program" means the Foster Youth Summer Internship Pilot Program (3)10 established under this section. The Secretary shall: 11 (b) 12 develop and implement a Foster Youth Summer Internship Pilot Program with the assistance of the Secretary of Human Resources and in consultation with 13 14 the local directors of local departments of social services; and 15 coordinate with State agencies to establish internships in State agencies that are open to participants in the Program. 16 17 The purpose of the Program is to provide foster youth with training and 18 experience through internships in agencies within the Executive Branch of State 19 government. 20 The Program shall be established in multiple regions of the State. (d) Internships under the Program may be paid or unpaid. 21 (e) 22(f) A State agency participating in the Program may: 23 specify requirements for internship applicants; and (1)24(2)select its interns from among the available applicants. 25 To be eligible to participate in an internship under the Program, an individual 26must be a foster youth at least 15 years old.
