- $\mathbf{5}$ FOR the purpose of authorizing the designation of an extraordinary development district 6 for certain purposes; authorizing the Maryland–National Capital Park and Planning 7 Commission to pledge enter into an agreement to pay all or a portion of certain 8 property taxes to Prince George's County for deposit into a certain special fund for 9 an extraordinary development district under certain circumstances; providing that 10 a certain agreement regarding an extraordinary development district must be 11 executed by the Commission and the governing body of Prince George's County; 12prohibiting the Commission from being an obligor for certain bonds; providing that 13 the Commission may not enter into a certain agreement regarding an extraordinary 14 development district until certain resolutions are adopted <del>or approved</del>; defining a certain term; altering a certain definition; and generally relating to extraordinary 1516 development districts in Prince George's County.

Article – Land Use Section 18-310 Annotated Code of Maryland (2012 Volume and 2015 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: **Article – Economic Development** 12 - 201. In this subtitle the following words have the meanings indicated. (a) "Adjusted assessable base" means the fair market value of real property that (b) qualifies for a farm or agricultural use under § 8–209 of the Tax – Property Article, without regard to the agricultural use assessment for the property as of January 1 of the year preceding the effective date of the resolution creating the development district under § 12–203 of this subtitle. "Assessable base" means the total assessable base, as determined by the (c)Supervisor of Assessments or the governing body in accordance with § 12–203(b) of this subtitle, of all real property subject to taxation in a development district or a sustainable community. "Assessment ratio" means a real property tax assessment ratio, (d)(1)however designated or calculated, that is used under applicable general law to determine the assessable base. "Assessment ratio" includes the assessment percentage specified under (2)§ 8–103(c) of the Tax – Property Article. "Bond" means a revenue bond, note, or other similar instrument issued in (e) accordance with this subtitle by: (1)a political subdivision; or the revenue authority of Prince George's County. (2)"Chief executive" means the president, chair, mayor, or other chief executive (f) officer of a political subdivision or the revenue authority of Prince George's County. (g) "Development" includes new development, redevelopment, revitalization, and renovation. (h)(1) "Development district" means a contiguous area designated by a resolution.

1 (a) (1) Subject to paragraph (2) of this subsection, the governing body of a 2 political subdivision that is not the issuer may pledge under an agreement that its property 3 taxes levied on the tax increment shall be paid into the special fund for the development 4 district, a RISE zone, or a sustainable community.

THE COMMISSION MAY NOT ENTER INTO AN AGREEMENT TO PLEDGE ITS PROPERTY TAXES WITH PRINCE GEORGE'S COUNTY TO PAY ALL OR A PORTION OF THE PROPERTY TAXES LEVIED BY THE COUNTY UNDER §§ 18–304, 18–306, AND 18–307 OF THIS SUBTITLE ON THE TAX INCREMENT IN AN EXTRAORDINARY DEVELOPMENT DISTRICT IN THE COUNTY TO THE COUNTY FOR DEPOSIT INTO A SPECIAL FUND FOR AN EXTRAORDINARY DEVELOPMENT DISTRICT UNDER § 12–210 OF THE ECONOMIC DEVELOPMENT ARTICLE UNTIL:

20 (1) THE GOVERNING BODY OF PRINCE GEORGE'S COUNTY HAS 21 ADOPTED A RESOLUTION DESIGNATING THE EXTRAORDINARY DEVELOPMENT 22 DISTRICT; AND

23 (2) THE PLANNING BOARD OF PRINCE GEORGE'S COUNTY
 24 <u>COMMISSION</u> HAS APPROVED ADOPTED A RESOLUTION IN SUPPORT OF APPROVING
 25 THE AGREEMENT.

26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 27 1, 2016.
