2 Vehicle Equipment – Counterfeit and Nonfunctional Airbags – Prohibitions

- 3 FOR the purpose of prohibiting a person from importing, manufacturing, distributing, 4 selling, or offering for sale a counterfeit airbag or a nonfunctional airbag; prohibiting $\mathbf{5}$ a person from installing a counterfeit airbag or a nonfunctional airbag in a motor 6 vehicle; prohibiting a person from selling or installing a device that causes the 7 vehicle diagnostic system to inaccurately indicate that the airbag is functional when 8 a counterfeit airbag, a nonfunctional airbag, or no airbag is installed; prohibiting a 9 person from representing to another person that a counterfeit airbag or a 10 nonfunctional airbag that is or will be installed in a motor vehicle is a functional 11 airbag; prohibiting a person from assisting in or causing a violation of this Act; 12establishing certain penalties for a violation of this Act; defining certain terms; and 13generally relating to motor vehicle equipment and counterfeit airbags and nonfunctional airbags. 14

(I) "AIRBAG" MEANS A MOTOR VEHICLE INFLATABLE 3 (2) 4 **OCCUPANT-RESTRAINT SYSTEM THAT:** $\mathbf{5}$ 1. **OPERATES IN THE EVENT OF A CRASH; AND** 6 2. IS DESIGNED IN ACCORDANCE WITH FEDERAL MOTOR 7VEHICLE SAFETY STANDARDS FOR THE SPECIFIC MAKE, MODEL, AND YEAR OF THE MOTOR VEHICLE IN WHICH IT IS OR WILL BE INSTALLED. 8 9 (II) "AIRBAG" INCLUDES THE COVER, SENSORS, CONTROLLERS, INFLATORS, WIRING, CUSHION MATERIAL, AND ANY OTHER COMPONENT PART OF AN 10 11 AIRBAG. HAS AN ELECTRICAL FAULT THAT IS DETECTED BY 20THE VEHICLE DIAGNOSTIC SYSTEM AFTER THE INSTALLATION PROCEDURE IS 21**COMPLETED; OR** 22(II) AN OBJECT, INCLUDING A COUNTERFEIT AIRBAG, INTENDED TO DECEIVE A VEHICLE OWNER OR OPERATOR INTO BELIEVING THAT THE 2324**OBJECT IS A FUNCTIONAL AIRBAG.** 25**(B)** A PERSON MAY NOT, WITH ACTUAL KNOWLEDGE OR KNOWLEDGE THAT ONE USING REASONABLE CARE OR DILIGENCE SHOULD POSSESS: 2627(1) IMPORT, MANUFACTURE, DISTRIBUTE, SELL, OR OFFER FOR SALE A COUNTERFEIT AIRBAG OR A NONFUNCTIONAL AIRBAG; 2829(2) INSTALL OR REINSTALL A COUNTERFEIT AIRBAG OR A 30 NONFUNCTIONAL AIRBAG IN A MOTOR VEHICLE;

1 (3) SELL, OFFER FOR SALE, INSTALL, OR REINSTALL A DEVICE IN A 2 VEHICLE THAT CAUSES THE VEHICLE'S DIAGNOSTIC SYSTEM TO INACCURATELY 3 INDICATE THAT THE VEHICLE IS EQUIPPED WITH A FUNCTIONAL AIRBAG WHEN A 4 COUNTERFEIT AIRBAG, NONFUNCTIONAL AIRBAG, OR NO AIRBAG IS INSTALLED;

5 (4) REPRESENT TO ANOTHER PERSON THAT A COUNTERFEIT AIRBAG
6 OR A NONFUNCTIONAL AIRBAG THAT IS OR WILL BE INSTALLED IN A MOTOR VEHICLE
7 IS A FUNCTIONAL AIRBAG; OR

(5) ASSIST IN OR CAUSE A VIOLATION OF THIS SUBSECTION.

9 (C) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A MISDEMEANOR 10 AND ON CONVICTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 5 YEARS OR A 11 FINE NOT EXCEEDING \$5,000 OR BOTH.

12 (D) THIS SECTION MAY BE CITED AS THE COUNTERFEIT AIRBAG 13 PREVENTION ACT.

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 15 October 1, 2016.
