1 AN ACT concerning

2 **Freestanding Birthing Centers – Use of Ultrasound Imaging**

3 FOR the purpose of requiring the Secretary of Health and Mental Hygiene, after
4 consultation with certain representatives, to establish by regulation certain
5 standards for the use of ultrasound imaging in a freestanding birthing center; and
6 generally relating to freestanding birthing centers and the use of ultrasound
7 imaging.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

19 That the Laws of Maryland read as follows:

2 19–3B–01.

3 (a) In this subtitle the following words have the meanings indicated.

4 (c) “Freestanding ambulatory care facility” means:

5 (1) An ambulatory surgical facility;

6 (2) A freestanding endoscopy facility;

7 (3) A freestanding facility utilizing major medical equipment;

8 (4) A kidney dialysis center; or

9 (5) A freestanding birthing center.

10 (d) (1) “Freestanding birthing center” means a facility that provides nurse
11 midwife services under Title 8, Subtitle 6 of the Health Occupations Article.

12 (2) “Freestanding birthing center” does not include:

13 (i) A hospital regulated under Subtitle 2 of this title; or

14 (ii) The private residence of the mother.

16 (a) (1) After consultation with representatives of payors, health care
17 practitioners, and **FREESTANDING** ambulatory care facilities, the Secretary shall by
18 regulation establish:

19 (i) Procedures to implement the provisions of this subtitle; and

20 (ii) Standards to ensure quality of care and patient safety that shall
21 include:22 1. Procedures for credentialing and practitioner performance
23 evaluation;24 2. Qualifications of health care practitioners and support
25 personnel;26 3. Procedures to be followed in the event of an emergency,
27 including a requirement that in the event of an emergency the patient be transported to
28 the nearest appropriate emergency care facility;

1 4. Procedures for quality control of any biomedical
2 equipment;

3 5. Procedures for postoperative recovery;

4 6. Procedures for discharge; [and]

5 7. THE USE OF ULTRASOUND IMAGING IN A
6 FREESTANDING BIRTHING CENTER; AND

7 [7.] 8. Any other procedures that the Secretary considers
8 necessary for quality of care and patient safety.

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
10 October 1, 2016.
