CHAPTER _____

1 AN ACT concerning

2 **Wicomico County Board of Education – Election and Appointment of Members**

3 FOR the purpose of requiring that, beginning with a certain election, certain members of
4 the Wicomico County Board of Education be elected by districts and certain members
5 be elected at large; providing that, alternatively, beginning with a certain election,
6 certain members of the Wicomico County Board of Education be elected by districts
7 and certain members be appointed; establishing the composition of the county board;
8 providing for the qualifications, terms of office, and filling of a vacancy of certain
9 members of the county board; establishing certain removal, hearing, and appeal
10 procedures for certain members of the county board; establishing a Wicomico County
11 School Board Nominating Commission to select nominees to be recommended to the
12 Wicomico County Council to fill certain appointments or vacancies on the county
13 board; providing for the membership and duties of the Commission; repealing certain
14 provisions concerning the appointment by the Governor of the members of the
15 Wicomico County Board of Education; providing for the termination of the terms of
16 certain members of the county board; submitting this Act to a referendum of the
17 qualified voters of Wicomico County for their adoption or rejection of certain
18 provisions of this Act; and generally relating to the election and appointment of the
19 members of the Wicomico County Board of Education.

7 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 8 That the Laws of Maryland read as follows:

9 **Article – Education**

10 3–105.

11 (a) Subsections (b), (c), and (d) of this section do not apply to a county if the
 12 number of members of the county board is regulated by other provisions of this title.

13 (b) If a county school system has an enrollment of less than 50,000 students, the
 14 county board shall have five members, except that:

15 (1) The Worcester County Board shall have the number of members
 16 provided in subsection (e) of this section; AND

17 (2) Any county board that had more than five members on July 1, 1969,
 18 shall retain that number of members[; and

19 (3) The Wicomico County Board shall have the number of members
 20 provided in subsection (f) of this section].

21 (c) If a county school system has an enrollment of 50,000 students or more but
 22 less than 100,000 students, the county board shall have seven members.

23 (d) If a county school system has an enrollment of 100,000 students or more, the
 24 county board shall have nine members except as provided in § 3–901 of this title for
 25 Montgomery County and § 3–1002 of this title for Prince George’s County.

26 (e) The Worcester County Board consists of seven voting members and one
 27 nonvoting student member from each public high school in the county.

28 [(f) (1) The Wicomico County Board consists of seven members.

29 (2) The term of a member is 5 years.]

19 (b) In Baltimore County, in accordance with Subtitle 2A of this title, the members

21 (c) In Caroline County, in accordance with Subtitle 3A of this title, the members
22 of the county board shall be a combination of members who are elected and appointed.

23 (d) In Harford County, in accordance with Subtitle 6A of this title, the members
24 of the county board shall be a combination of members who are elected and appointed.

1 (e) In Prince George's County, in accordance with Subtitle 10 of this title, the
2 members of the county board shall be a combination of members who are elected and
3 appointed.

4 (f) An individual subject to the authority of the county board may not serve as a
5 member of the county board. At the time of filing a certificate of candidacy for election to a
6 county board, a person shall certify to the local board of supervisors of elections whether or
7 not the person is subject to the authority of the county board. The Governor may not issue
8 a commission of election to a person who has certified affirmatively and who is elected to a
9 county board until the member-elect offers proof that the member-elect is no longer subject
10 to the authority of the county board.

11 (g) The election of the county boards shall be held as provided in Subtitles 2
12 through 14 of this title and the Election Law Article.

15 (A) (1) THE WICOMICO COUNTY BOARD CONSISTS OF SEVEN
16 NONPARTISAN ELECTED VOTING MEMBERS.

17 (2) THE SEVEN MEMBERS SHALL BE ELECTED AS FOLLOWS:

18 (I) ONE MEMBER FROM EACH OF THE FIVE COUNCILMANIC
19 DISTRICTS IN THE COUNTY, ELECTED BY THE VOTERS OF THAT DISTRICT; AND

20 (II) TWO MEMBERS AT LARGE, ELECTED BY THE VOTERS OF THE
21 COUNTY.

22 (B) (1) A CANDIDATE WHO BECOMES AN ELECTED MEMBER OF THE
23 COUNTY BOARD MUST BE A RESIDENT AND REGISTERED VOTER OF WICOMICO
24 COUNTY.

25 (2) (I) AN ELECTED MEMBER WHO NO LONGER RESIDES IN
26 WICOMICO COUNTY MAY NOT CONTINUE AS A MEMBER OF THE BOARD.

27 (II) A MEMBER ELECTED FROM A COUNCILMANIC DISTRICT
28 WHO NO LONGER RESIDES IN THAT DISTRICT MAY NOT CONTINUE AS A MEMBER OF
29 THE BOARD.

30 (3) IF THE BOUNDARY LINE OF A WICOMICO COUNTY COUNCILMANIC
31 DISTRICT IS CHANGED, THE TERM OF AN INCUMBENT MEMBER OF THE COUNTY

1 BOARD WHO NO LONGER RESIDES IN THAT COUNCILMANIC DISTRICT BECAUSE OF
2 THE CHANGE IS NOT AFFECTED DURING THIS TERM.

4 (A) THE SEVEN MEMBERS OF THE WICOMICO COUNTY BOARD SHALL BE
5 ELECTED:

6 (1) AT THE GENERAL ELECTION IN 2018 AND AT THE GENERAL
7 ELECTION EVERY 4 YEARS THEREAFTER; AND

8 (2) IN ACCORDANCE WITH § 3-13A-01 OF THIS SUBTITLE AND TITLE
9 8, SUBTITLE 8 OF THIS ARTICLE.

3 (4) (I) WITHIN 60 DAYS AFTER THE COUNTY COUNCIL RECEIVES
4 THE NAMES OF THE NOMINEES FROM THE COMMISSION, THE COUNTY COUNCIL
5 SHALL HOLD A PUBLIC HEARING REGARDING THE NOMINEES.

6 (II) AFTER THE HEARING, IF THE COUNTY COUNCIL DEEMS AT
7 LEAST ONE OF THE NOMINEES ACCEPTABLE, THE COUNTY COUNCIL SHALL VOTE ON
8 THE NOMINEES AND FILL THE VACANCY.

9 (III) IF THE COUNTY COUNCIL DEEMS BOTH NOMINEES
10 UNACCEPTABLE, THE COUNTY COUNCIL SHALL RETURN THE NAMES TO THE
11 COMMISSION AND REQUEST THAT THE COMMISSION SUBMIT THE NAMES OF AT
12 LEAST TWO ADDITIONAL QUALIFIED NOMINEES FROM WHICH THE COUNTY
13 COUNCIL SHALL SELECT AN INDIVIDUAL TO FILL THE VACANCY.

14 (5) (I) THE COMMISSION CONSISTS OF 14 MEMBERS.

15 (II) THE MEMBERS OF THE COMMISSION SHALL BE APPOINTED
16 BY THE COUNTY EXECUTIVE OF WICOMICO COUNTY, SUBJECT TO CONFIRMATION
17 BY THE COUNTY COUNCIL, FROM THE NAMES SUBMITTED BY THE FOLLOWING
18 ORGANIZATIONS, ENTITIES, OR COMMUNITIES OF INTEREST:

19 1. ONE MEMBER FROM THE WICOMICO COUNTY
20 BRANCH OF THE NATIONAL ASSOCIATION FOR THE ADVANCEMENT OF COLORED
21 PEOPLE;

22 2. ONE MEMBER FROM THE WICOMICO COUNTY
23 EDUCATION ASSOCIATION;

24 3. ONE MEMBER FROM THE WICOMICO COUNTY AREA
25 CHAMBERS OF COMMERCE, SELECTED BY THE CHAMBERS BY CONSENSUS;

26 4. ONE MEMBER FROM THE WICOMICO COUNTY
27 EDUCATIONAL SUPPORT PROFESSIONALS ASSOCIATION;

28 5. ONE MEMBER FROM THE WICOMICO COUNTY
29 COUNCIL OF PTAS;

30 6. ONE MEMBER FROM EACH OF THE EIGHT
31 INCORPORATED MUNICIPALITIES IN WICOMICO COUNTY; AND

1 **7. ONE MEMBER WHO IS A PARENT OF A CHILD WITH**
2 **SPECIAL NEEDS IN THE WICOMICO COUNTY PUBLIC SCHOOL SYSTEM AND WHO IS**
3 **AFFILIATED WITH AN ADVOCACY GROUP FOR CHILDREN WITH SPECIAL NEEDS IN**
4 **THE COUNTY.**

5 **(6) TO THE EXTENT PRACTICABLE, THE COMMISSION SHALL**
6 **REFLECT THE GENDER, ETHNIC, AND RACIAL MAKEUP OF THE COUNTY.**

7 **(7) THE COUNTY EXECUTIVE OF WICOMICO COUNTY SHALL APPOINT**
8 **THE MEMBERS OF THE COMMISSION, WITH THE ADVICE AND CONSENT OF THE**
9 **COUNTY COUNCIL, FROM THE NAMES SUBMITTED BY THE ORGANIZATIONS,**
10 **ENTITIES, OR COMMUNITIES OF INTEREST LISTED UNDER PARAGRAPH (5) OF THIS**
11 **SUBSECTION.**

12 **(8) THE TERM OF A MEMBER OF THE COMMISSION IS 4 YEARS.**

13 **(9) THE COMMISSION SHALL SELECT A CHAIR AND VICE CHAIR FROM**
14 **AMONG THE MEMBERS.**

15 **(B) THE WICOMICO COUNTY PUBLIC SCHOOL SYSTEM SHALL PROVIDE**
16 **STAFF FOR THE COMMISSION.**

11 **COUNTY COUNCIL FROM THE COUNTY AT LARGE.**

12 (2) (I) **THE FIVE ELECTED MEMBERS SHALL BE ELECTED AT A**
13 **GENERAL ELECTION IN ACCORDANCE WITH § 3-13A-02 OF THIS SUBTITLE AND**
14 **TITLE 8, SUBTITLE 8 OF THIS ARTICLE.**

15 (II) **THE TWO APPOINTED MEMBERS SHALL BE APPOINTED BY**
16 **THE WICOMICO COUNTY COUNCIL FROM A LIST OF NOMINEES SUBMITTED BY THE**
17 **WICOMICO COUNTY SCHOOL BOARD NOMINATING COMMISSION AS PROVIDED IN §**
18 **3-13A-03 OF THIS SUBTITLE:**

19 1. **ON THE EXPIRATION OF THE TERM OF AN INCUMBENT**
20 **APPOINTED MEMBER AND WITHIN 30 DAYS AFTER THE GENERAL ELECTION; OR**

22 **UNDER THIS SUBTITLE.**

23 (3) (I) **A MEMBER FROM A DISTRICT MUST BE AT LEAST 21 YEARS**
24 **OLD, A RESIDENT OF THAT DISTRICT FOR AT LEAST 2 YEARS, AND A REGISTERED**
25 **VOTER OF THE COUNTY BEFORE THE ELECTION.**

26 (II) **A MEMBER FROM A DISTRICT WHO DOES NOT MAINTAIN**
27 **RESIDENCY IN THAT DISTRICT MAY NOT CONTINUE AS A MEMBER OF THE COUNTY**
28 **BOARD AND THE OFFICE SHALL BE DEEMED VACANT.**

1 (III) IF THE BOUNDARY LINE OF A DISTRICT IS CHANGED, THE
2 TERM OF AN INCUMBENT MEMBER OF THE COUNTY BOARD WHO NO LONGER

17 VACANCY NO LATER THAN 30 DAYS AFTER THE GENERAL ELECTION.

20 **MONDAY IN DECEMBER, IN THE YEAR IN WHICH THE GOVERNOR IS ELECTED, AFTER**
21 **THE MEMBER'S ELECTION OR APPOINTMENT AND UNTIL A SUCCESSOR IS ELECTED**
22 **OR APPOINTED AND QUALIFIES.**

23 **(2) (I) THE INITIAL TERM OF THE TWO MEMBERS AT LARGE OF THE**

22 **AT THE FIRST MEETING OF THE COUNTY BOARD IN DECEMBER OF EACH YEAR,**

25 **SECTION 3. AND BE IT FURTHER ENACTED,** That the terms of the members of
26 the Wicomico County Board of Education in office at the end of December 2, 2018, shall
27 expire at the end of December 2, 2018.

28 **SECTION 4. AND BE IT FURTHER ENACTED,** That before this Act becomes
29 effective it shall first be submitted to a referendum of the qualified voters of Wicomico

1 County at the general election to be held in November of 2016. The cost of the election shall
 2 be paid by the County governing body. The County governing body and the Wicomico
 3 County Board of Elections shall do those things necessary and proper to provide for and
 4 hold the referendum required by this section. There shall be printed on the ballot to be used
 5 at this election the title of this Act and underneath the title, on separate lines, a square or
 6 box for each of the following questions:

7 Question 1: “For Retaining the Current System, a Board of Education with Seven
 8 Members Appointed by the Governor”;

9 Question 2: “For a Board of Education with Five Members Elected by District and
 10 Two Members Elected At Large”; and

11 Question 3: “For a Board of Education with Five Members Elected by District and
 12 Two Members Appointed by the Wicomico County Council”.

13 A voter may cast a vote only on one of the questions.

14 If the highest number of the votes cast on the three questions is “For Retaining the
 15 Current System, a Board of Education with Seven Members Appointed by the Governor”,
 16 the provisions of Sections 1, 2, and 3 of this Act are of no effect and null and void. If the
 17 highest number of votes cast on the three questions is “For a Board of Education with Five
 18 Members Elected by District and Two Members Elected At Large”, the provisions of Section
 19 2 of this Act are of no effect and null and void. If the highest number of votes cast on the
 20 three questions is “For a Board of Education with Five Members Elected by District and
 21 Two Members Appointed by the Wicomico County Council”, the provisions of Section 1 of
 22 this Act are of no effect and null and void.

23 SECTION 5. AND BE IT FURTHER ENACTED, That, subject to the provisions of
 24 Section 4 of this Act and for the sole purpose of providing for the referendum required by
 25 Section 4 of this Act, this Act shall take effect July 1, 2016.
