2 **Property Tax – Appeals – Provision of Information to Taxpayers**

3 FOR the purpose of requiring that a person making a certain appeal before a supervisor of
4 assessments receive certain information from the Department of Assessments and
5 Taxation regarding the property that is the subject of the appeal and a certain sales
6 analysis at least a certain number of days before a certain hearing; requiring the
7 Department to provide the information free of charge; repealing certain provisions
8 of law relating to a request by a person making an appeal before a property tax
9 assessment appeal board for certain information; requiring that a person making a
10 certain appeal before a property tax assessment appeal board receive certain
11 information from the Department regarding comparable properties at least a certain
12 number of days before a certain hearing; requiring the Department to provide the
13 information free of charge; repealing the authority of the Department to charge a fee
14 for the information; requiring the Department to provide certain information to a

21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 22 That the Laws of Maryland read as follows:

25 **(A) FOR A HEARING BEFORE A SUPERVISOR THAT RELATES TO THE VALUE**
 26 **OF PROPERTY, THE PERSON MAKING THE APPEAL SHALL RECEIVE AT LEAST 14 DAYS**
 27 **BEFORE THE HEARING:**

28 **(1) THE ASSESSMENT WORKSHEET OR CARD FOR THE PROPERTY**
 29 **THAT IS THE SUBJECT OF THE APPEAL; AND**

30 **(2) THE SALES ANALYSIS FOR THE NEIGHBORHOOD OR PROPERTY**
 31 **TYPE OF THE PROPERTY THAT IS THE SUBJECT OF THE APPEAL.**

32 **(B) THE DEPARTMENT SHALL PROVIDE THE INFORMATION REQUIRED**
 33 **UNDER THIS SECTION FREE OF CHARGE.**

34 **(C) (1) IF A PERSON MAKING AN APPEAL BEFORE A SUPERVISOR**
 35 **APPEARS AT THE SCHEDULED HEARING AND STATES THAT THE DEPARTMENT HAS**

1 NOT PROVIDED THE INFORMATION REQUIRED UNDER THIS SECTION, THE
2 DEPARTMENT SHALL IMMEDIATELY PROVIDE THE INFORMATION.

11 OF THE PERSON MAKING THE APPEAL TO A DATE THAT IS 14 OR MORE DAYS AFTER
12 THE PREVIOUSLY SCHEDULED HEARING DATE.

14 (a) (1) For a hearing before a property tax assessment appeal board THAT
15 RELATES TO THE VALUE OF PROPERTY, the person making the appeal [may submit a
16 written request to the supervisor,] SHALL RECEIVE at least [15] 30 days before the
17 hearing[, for] a list of other COMPARABLE properties [that will be used as comparables by
18 the supervisor at the scheduled hearing].

19 (2) [The supervisor shall supply the list:

20 (i) at least 30 days before the date that the hearing has been
21 scheduled for a written request made at least 35 days before the hearing; or

22 (ii) within 5 days from the request for a request made between 35
23 days and 15 days before the hearing.

24 (3) The list shall identify the location and owner of each COMPARABLE
25 property.

26 [(4)](3) [If the supervisor will use the information in the appeal, the]
27 THE list shall also include for each COMPARABLE property on the list:

28 (i) the sale price and date of sale;

29 (ii) the assessment and the year or years to which the assessment
30 applied; and

31 (iii) the construction costs and the date of construction.

 17 **OPTION OF THE PERSON MAKING THE APPEAL TO A DATE THAT IS 30 OR MORE DAYS**
 18 **AFTER THE PREVIOUSLY SCHEDULED HEARING DATE.**
