2 3 4	(d) (1) In this subsection, "Deer Management Permit" means a permit issued by the Department authorizing the holder to hunt deer outside of deer hunting season for the purpose of preventing damage to crops.
5 6	(2) (i) In Charles County and St. Mary's County, an individual who holds a Deer Management Permit may:
7 8 9 10	1. Use a shotgun or breech loading center fired rifle approved by the Department to hunt deer throughout [deer season] THE YEAR, INCLUDING ALL DEER HUNTING SEASONS, in the locations and under the conditions set forth in the permit; and
11 12 13	2. If the individual leases State land in Charles County or St. Mary's County for the purpose of cultivating crops, hunt deer on the land leased by the individual in the locations and under the conditions set forth in the permit.
14 15	(ii) The Department may authorize an individual in Charles County or St. Mary's County to hunt deer on Sundays under a Deer Management Permit.
16 17	(3) To protect public safety and welfare, the Department may restrict the lands on which an individual may hunt deer under a Deer Management Permit.
18 19	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2016.
