A BILL ENTITLED

1 AN ACT concerning

2 **State Board of Massage Therapy Examiners – Licensure, Registration, and**
3 **Regulation**

4 FOR the purpose of establishing the State Board of Massage Therapy Examiners in the
5 Department of Health and Mental Hygiene; renaming the State Board of
6 Chiropractic and Massage Therapy Examiners to be the State Board of Chiropractic
7 Examiners, altering the membership of the State Board of Chiropractic Examiners,
8 and transferring certain authority to license massage therapists and register
9 massage practitioners to the State Board of Massage Therapy Examiners; providing
10 for the composition, appointment, removal, terms, officers, compensation, and
11 reimbursement for the expenses of the State Board of Massage Therapy Examiners
12 members; establishing certain powers and duties of the Board; authorizing certain
13 boards to employ a certain staff; requiring certain boards to jointly appoint an
14 executive director; providing that the executive director has the powers and duties
15 assigned by certain boards; providing for a certain quorum of members of the Board;
16 establishing a certain fund; authorizing the Board to set certain fees; requiring
17 certain fees collected by the Board to be paid to the Comptroller; requiring the
18 Comptroller to distribute certain fees to a certain fund; providing for the
19 administration and audit of the fund and the purpose for which the fund may be
20 used; requiring that persons who give information to the Board or participate in
21 certain Board activities have the immunity from liability described in certain
22 provisions of law; requiring an individual to be licensed or registered by the Board
23 before the individual may practice massage therapy in the State or in certain
24 settings in the State; establishing certain exceptions; establishing certain
25 education, experience, criminal history records check, and examination
26 requirements for licensed massage therapists and registered massage practitioners;
27 establishing certain requirements for qualifying, renewing, reinstating, and
28 surrendering a license for massage therapists or registration for massage
29 practitioners; establishing certain requirements for submitting fingerprints to the
30 Criminal Justice Information System Central Repository of the Department of Public
31 Safety and Correctional Services under certain circumstances; requiring the Central

1 Repository to forward to the Board and certain applicants certain criminal history
2 record information; establishing certain requirements for applying for a license or
3 registration; requiring the Board to issue a license or registration under certain
4 circumstances; authorizing the Board to deny a license or registration to an
5 applicant, refuse to renew a license or registration, reprimand a licensed massage
6 therapist or registered massage practitioner, suspend or revoke a license or
7 registration, or impose certain penalties under certain circumstances; establishing
8 certain hearing and appeal procedures for massage therapists and massage
9 practitioners; authorizing a certain action to be maintained to enjoin certain
10 unauthorized practice or conduct under certain circumstances; providing that
11 certain provisions of this Act do not limit the right of a certain individual to practice
12 or advertise an occupation; requiring the Board to adopt regulations to establish
13 standards for advertising or soliciting by licensed massage therapists and registered
14 massage practitioners; establishing requirements for the use of a trade name by
15 licensed massage therapists and registered massage practitioners; prohibiting a
16 certain health care provider from referring patients to an individual who is not a
17 licensed massage therapist; providing that certain health insurance carriers and
18 third party administrators are not required to reimburse a licensed massage
19 therapist or registered massage practitioner for services rendered; providing for the
20 purpose and function of a certain rehabilitation committee; recodifying certain
21 provisions of law that authorize certain counties to adopt certain ordinances and
22 regulations and require certain county commissioners to provide certain authority
23 to certain officers and offices to carry out certain regulations and ordinances;
24 prohibiting an individual from practicing, attempting to practice, or offering to practice
25 massage therapy in the State without a license or registration; prohibiting certain
26 individuals from making certain representations to the public, using certain titles, and
27 using certain initials; prohibiting certain persons from misrepresenting an
28 individual's status of licensure or registration as a massage therapist or massage
29 practitioner by the Board; establishing certain restrictions on the advertising of
30 nonmedical massage services; recodifying certain provisions of law that prohibit
31 certain individuals from performing a massage or offering to perform a massage for
32 compensation in certain counties without a license or registration and authorize
33 certain law enforcement to demand proof of licensure or registration; prohibiting a
34 person from buying, selling, or fraudulently obtaining a certain license, registration,
35 diploma, or degree; requiring a certain individual to reimburse the Board for certain
36 costs; establishing certain criminal penalties; establishing a certain short title;
37 requiring that an evaluation of the Board, and the statutes and regulations that
38 relate to the Board, be performed on or before a certain date; providing for the
39 termination of this Act under certain circumstances; providing that certain
40 positions on a certain board shall terminate as of a certain date; specifying the terms
41 of the initial members of the Board; providing for the transition between certain
42 boards of the regulation, licensure, and registration of massage therapists and
43 massage practitioners; requiring certain employees of a certain board to become
44 employees of certain boards established under certain provisions of this Act;
45 defining certain terms; making certain technical and conforming changes; and
46 generally relating to the establishment of the State Board of Massage Therapy

 18 That Section(s) 8–403(b)(36) through (57), respectively, of Article – State Government of

25 (i) [6] 5 shall be licensed chiropractors; AND

26 (ii) [3 shall be licensed massage therapists; and

27 (iii)] 2 shall be consumer members.

1 (3) (i) The Governor shall appoint the chiropractor members, with the
2 advice of the Secretary, and with the advice and consent of the Senate, from a list of
3 qualified individuals submitted to the Governor by the Maryland Chiropractic Association.

4 (ii) The number of names on the list shall be five times the number
5 of vacancies.

6 (iii) The list shall include the name of the incumbent member unless
7 the incumbent declines renomination.

8 [(4) (i) The Governor shall appoint the massage therapist members,
9 with the advice of the Secretary, and with the advice and consent of the Senate, from a list
10 of qualified individuals submitted to the Governor by the American Massage Therapy
11 Association, Maryland Chapter.

12 (ii) The number of names on the list shall be five times the number
13 of vacancies.

14 (iii) The list shall include the name of the incumbent member unless
15 the incumbent declines renomination.]

16 [(5) (4) The Governor shall appoint the consumer members with the
17 advice of the Secretary, and with the advice and consent of the Senate.

18 (b) Each chiropractor member of the Board shall be:

19 (1) A resident of this State;

20 (2) A licensed chiropractor of integrity and ability who is in active practice;

21 (3) A graduate of a resident course in chiropractic; and

22 (4) An individual who has practiced chiropractic in this State for at least 5
23 consecutive years.

24 [(c) Each massage therapist member of the Board shall be:

25 (1) A resident of this State;

26 (2) A licensed massage therapist of integrity and ability who is in active
27 practice;

28 (3) A graduate of a Board–approved course in massage therapy; and

29 (4) An individual who has practiced massage therapy in this State for at
30 least 5 consecutive years.]

1 [(d)] (C) Each consumer member of the Board:

2 (1) Shall be a member of the general public;

3 (2) May not be or ever have been a chiropractor [or massage therapist] or
4 in training to become a chiropractor [or massage therapist];

5 (3) May not have a household member who is a chiropractor [or massage
6 therapist] or in training to become a chiropractor [or massage therapist];

7 (4) May not participate or ever have participated in a commercial or
8 professional field related to chiropractic [or massage therapy];

9 (5) May not have a household member who participates in a commercial or
10 professional field related to chiropractic [or massage therapy]; and

11 (6) May not have had, within 2 years before appointment, a substantial
12 financial interest in a person regulated by the Board.

13 [(e)] (D) (1) In addition to the requirements of [subsections (b) and (c)]
14 **SUBSECTION (B)** of this section, each chiropractic [and massage therapy] member of the
15 Board shall be a licensed chiropractor [or licensed massage therapist] whose license is in
16 good standing with the Board.

17 (2) For purposes of this subsection, “good standing” means that the Board
18 has not reprimanded the licensee, suspended or revoked the license of the chiropractor [or
19 massage therapist], or placed the licensee on probation within 5 years prior to or after
20 confirmation to the Board.

21 [(f)] (E) While a member of the Board, a consumer member may not have a
22 substantial financial interest in a person regulated by the Board.

23 [(g)] (F) Before taking office, each appointee to the Board shall take the oath
24 required by Article I, § 9 of the Maryland Constitution.

25 [(h)] (G) (1) The term of a member is 4 years.

26 (2) The terms of members are staggered as required by the terms provided
27 for members of the Board on October 1, [2008] **2016**.

28 (3) At the end of a term, a member continues to serve until a successor is
29 appointed and qualifies.

30 (4) A member who is appointed after a term has begun serves only for the
31 rest of the term and until a successor is appointed and qualifies.

1 (5) The Governor shall fill any vacancy on the Board within 60 days of the
2 date of the vacancy.

3 (6) A member may not serve more than 2 consecutive full terms.

4 **[(i)] (H)** (1) The Governor may remove a member for incompetence or
5 misconduct.

6 (2) Upon the recommendation of the Secretary, the Governor may remove
7 a member whom the Secretary finds to have been absent from 2 successive Board meetings
8 without adequate reason.

10 (d) **(1)** The Board **AND THE STATE BOARD OF MASSAGE THERAPY**
11 **EXAMINERS** may employ a staff in accordance with the **[budget of the Board]** **BUDGETS**
12 **OF THE BOARDS.**

13 **(2) THE BOARD AND THE STATE BOARD OF MASSAGE THERAPY**
14 **EXAMINERS JOINTLY SHALL APPOINT A STAFF MEMBER AS THE EXECUTIVE**

21 Fund.

23 (a) Except as otherwise provided in the Administrative Procedure Act, before the
24 Board takes any action under § 3-313 of this subtitle **[or § 3-5A-10 of this title]**, it shall
25 give the individual against whom the action is contemplated an opportunity for a hearing
26 before the Board.

27 (g) If, after a hearing, a chiropractor **[or massage therapist]** is found in violation
28 of § 3-313 of this subtitle **[or § 3-5A-10 of this title]**, the chiropractor **[or massage**
29 **therapist]** shall pay to the Board the costs for court reporting services.

1 (a) Except as provided in this section for an action under § 3–313 of this subtitle
2 [or § 3–5A–10 of this title], any person aggrieved by a final decision of the Board in a
3 contested case, as defined in the Administrative Procedure Act, may petition for judicial
4 review as allowed by the Administrative Procedure Act.

5 (b) Any person aggrieved by a final decision of the Board under § 3–313 of this
6 subtitle [or § 3–5A–10 of this title] may not appeal to the Secretary but may take a direct

9 (a) An action may be maintained in the name of this State or the Board to enjoin:

10 (1) The unauthorized practice of chiropractic [or massage therapy]; or

11 (2) Conduct that is a ground for disciplinary action under § 3–313 of this

13 (d) (1) Except as provided in paragraph (2) of this subsection, an action under
14 this section may not be brought against an individual who is authorized to practice a health
15 occupation under this article.

16 (2) An action under this section may be brought against an individual who
17 is authorized to practice chiropractic [or massage therapy] under this title.

18 (f) An action under this section is in addition to and not instead of criminal
19 prosecution for[:

20 (1) The] **THE** unauthorized practice of chiropractic under § 3–501 of this
21 title or disciplinary action under § 3–313 of this subtitle[; or

22 (2) The unauthorized practice of massage therapy under § 3–501 of this
23 title or disciplinary action under § 3–5A–10 of this title].

24 3–501.

25 [(a)] Except as otherwise provided in § 3–404 of this title, a person may not practice,
26 attempt to practice, or offer to practice chiropractic in this State unless licensed by the
27 Board.

28 [(b)] Except as otherwise provided in this title, an individual may not practice,
29 attempt to practice, or offer to practice massage therapy, massage, myotherapy, or any
30 synonym or derivation of these terms in this State unless licensed or registered by the
31 Board.]

1 3–502.

2 (a) [(1)] Unless authorized to practice chiropractic under this title, a person may
3 not represent to the public by title, by description of services, methods, or procedures, or
4 otherwise, that the person is authorized to practice chiropractic in this State.

5 [(2)] (B) Unless authorized to practice under this title, a person may not
6 use the title “chiropractor”, or “D.C.”, or any other term or title with the intent to represent
7 that the person practices chiropractic.

8 [(b) (1)] An individual who is not a licensed massage therapist or registered as
9 a massage practitioner under this title may not advertise or claim by title, abbreviation,
10 sign, card, or any other representation that the individual practices massage, massage
11 therapy, myotherapy, or any synonym or derivation of these terms.

12 (2) Unless authorized to practice under this title, a person may not use the
13 title “massage therapist”, “MT”, “licensed massage therapist”, “LMT”, “massage
14 practitioner”, “MP”, “registered massage practitioner”, “RMP”, or any other term or title
15 with the intent to represent that the person practices massage therapy.

16 (c) An individual who is a registered massage practitioner under this title or a
17 business entity that employs registered massage practitioners under this title may not
18 advertise to the public that the individual or business entity provides health–related
19 therapeutic massage services.

20 (d) (1) In Charles County and Washington County, an individual may not
21 perform a massage or offer to perform a massage on another person for compensation unless
22 the individual who performs the massage or offers to perform a massage is a licensed
23 massage therapist or registered massage practitioner.

24 (2) A law enforcement officer in Charles County or Washington County
25 may demand proof of licensure or registration.]

27 A person may not buy, sell, or fraudulently obtain:

28 (1) A license; or

29 (2) Any diploma or degree required under § 3–302 [or § 3–5A–06] of this
30 title.

31 3–506.

32 (a) A person who practices or attempts to practice chiropractic [or massage
33 therapy] without a license in violation of § 3–501 of this subtitle or represents to the public

1 in violation of § 3–502 of this subtitle that the person is authorized to practice chiropractic
2 [or massage therapy] is guilty of a misdemeanor and on conviction is subject to:

3 (1) For a first offense, a fine not exceeding \$2,000 or imprisonment not
4 exceeding 6 months; or

5 (2) For a subsequent offense, a fine not exceeding \$6,000 or imprisonment
6 not exceeding 1 year.

8 SUBTITLE 1. DEFINITIONS; GENERAL PROVISIONS.

9 6–101.

10 (A) IN THIS TITLE THE FOLLOWING WORDS HAVE THE MEANINGS
11 INDICATED.

12 (B) “BOARD” MEANS THE STATE BOARD OF MASSAGE THERAPY
13 EXAMINERS.

14 (C) “HEALTH CARE SETTING” MEANS:

15 (1) THE OFFICE OF A HEALTH CARE PROVIDER REGULATED UNDER
16 THIS ARTICLE; OR

17 (2) A HEALTH CARE FACILITY AS DEFINED IN § 19–114 OF THE
18 HEALTH – GENERAL ARTICLE.

19 (D) “LICENSE” MEANS, UNLESS THE CONTEXT REQUIRES OTHERWISE, A
20 LICENSE ISSUED BY THE BOARD TO PRACTICE MASSAGE THERAPY.

21 (E) “LICENSED MASSAGE THERAPIST” MEANS AN INDIVIDUAL WHO IS
22 LICENSED BY THE BOARD TO PRACTICE MASSAGE THERAPY.

23 (F) (1) “MASSAGE THERAPY” MEANS THE USE OF MANUAL TECHNIQUES
24 ON SOFT TISSUES OF THE HUMAN BODY INCLUDING EFFLEURAGE (STROKING),
25 PETRISSAGE (KNEADING), TAPOTEMENT (TAPPING), STRETCHING, COMPRESSION,
26 VIBRATION, AND FRICTION, WITH OR WITHOUT THE AID OF HEAT LIMITED TO HOT
27 PACKS AND HEATING PADS, COLD WATER, OR NONLEGEND TOPICAL APPLICATIONS,
28 FOR THE PURPOSE OF IMPROVING CIRCULATION, ENHANCING MUSCLE
29 RELAXATION, RELIEVING MUSCULAR PAIN, REDUCING STRESS, OR PROMOTING
30 HEALTH AND WELL-BEING.

1 **(2) “MASSAGE THERAPY” INCLUDES THE LAYING ON OF HANDS,**
2 **CONSISTING OF PRESSURE OR MOVEMENT ON AN INDIVIDUAL WHO IS FULLY**
3 **CLOTHED, EXCEPT FOR FOOTWEAR, TO SPECIFICALLY AFFECT THE**
4 **ELECTROMAGNETIC ENERGY OR ENERGETIC FIELD OF THE HUMAN BODY IF THIS**
5 **PRACTICE INCLUDES USE OF THE MANUAL TECHNIQUES SET FORTH IN PARAGRAPH**
6 **(1) OF THIS SUBSECTION.**

7 **(3) “MASSAGE THERAPY” DOES NOT INCLUDE:**

8 **(I) THE DIAGNOSIS OR TREATMENT OF ILLNESS, DISEASE, OR**
9 **INJURY;**

10 **(II) THE ADJUSTMENT, MANIPULATION, OR MOBILIZATION OF**
11 **ANY OF THE ARTICULATIONS OF THE OSSEOUS STRUCTURES OF THE HUMAN BODY**
12 **OR SPINE; OR**

13 **(III) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**
14 **SUBSECTION, THE LAYING ON OF HANDS, CONSISTING OF PRESSURE OR MOVEMENT**
15 **ON AN INDIVIDUAL WHO IS FULLY CLOTHED, EXCEPT FOR FOOTWEAR, TO**
16 **SPECIFICALLY AFFECT THE ELECTROMAGNETIC ENERGY OR ENERGETIC FIELD OF**
17 **THE HUMAN BODY.**

18 **(4) THE PROVISIONS OF PARAGRAPH (3) OF THIS SUBSECTION DO**
19 **NOT PRECLUDE THE APPLICATION OF THE MODALITIES DESCRIBED IN PARAGRAPH**
20 **(1) OF THIS SUBSECTION TO AN INDIVIDUAL WHO HAS AN INJURY.**

21 **(G) “PRACTICE MASSAGE THERAPY” MEANS TO ENGAGE PROFESSIONALLY**
22 **AND FOR COMPENSATION IN MASSAGE THERAPY.**

23 **(H) “REGISTERED MASSAGE PRACTITIONER” MEANS AN INDIVIDUAL WHO IS**
24 **REGISTERED BY THE BOARD TO PRACTICE MASSAGE THERAPY IN A SETTING THAT**
25 **IS NOT A HEALTH CARE SETTING.**

26 **(I) “REGISTRATION” MEANS, UNLESS THE CONTEXT REQUIRES**
27 **OTHERWISE, A REGISTRATION ISSUED BY THE BOARD TO PRACTICE MASSAGE**
28 **THERAPY IN A SETTING THAT IS NOT A HEALTH CARE SETTING.**

29 **6-102.**

30 **EXCEPT AS SPECIFICALLY PROVIDED IN THIS TITLE, THIS TITLE DOES NOT**
31 **LIMIT THE RIGHT OF AN INDIVIDUAL TO PRACTICE OR ADVERTISE AN OCCUPATION**
32 **THAT THE INDIVIDUAL OTHERWISE IS AUTHORIZED TO PRACTICE UNDER THIS**
33 **ARTICLE.**

1 **SUBTITLE 2. STATE BOARD OF MASSAGE THERAPY EXAMINERS.**

2 **6-201.**

11 the licensed massage therapist members of the Board shall terminate so as to reduce the
12 number of positions on the newly established State Board of Chiropractic Examiners in
