FOR the purpose of prohibiting certain entity names from being registered with the State
Department of Assessments and Taxation except under certain circumstances;
requiring the Department to make a certain determination under certain
circumstances; prohibiting the Department from registering a certain entity name
under certain circumstances; prohibiting the registration of a certain entity name
for a certain period of time under certain circumstances; and generally relating to
registering entity names with the State Department of Assessments and Taxation.

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 That the Laws of Maryland read as follows:

Article – Corporations and Associations

19 **1–509.**

20 (A) (1) AN ENTITY NAME THAT INDICATES THE ENTITY NAME WILL BE 21 USED FOR A PROFESSION OR AN OCCUPATION THAT REQUIRES LICENSURE MAY NOT 22 BE REGISTERED WITH THE DEPARTMENT UNLESS THE ENTITY HAS THE 23 APPROPRIATE LICENSURE.

1 (2) THE DEPARTMENT SHALL DETERMINE WHETHER THE ENTITY 2 HAS THE APPROPRIATE LICENSURE AND, IF NOT, MAY NOT REGISTER THE ENTITY 3 NAME.

4 **(B)** AN ENTITY NAME THAT INCLUDES THE NAME OF AN INDIVIDUAL MAY 5 NOT BE REGISTERED WITH THE DEPARTMENT UNLESS THE ENTITY REGISTERING 6 THE NAME IS THAT INDIVIDUAL.

7 (C) IF AN ENTITY HAS FORFEITED THE RIGHT TO DO BUSINESS IN 8 MARYLAND, AND THE RIGHT TO USE THE ENTITY NAME IS FORFEITED, THE ENTITY 9 NAME MAY NOT BE REGISTERED WITH THE DEPARTMENT UNTIL AT LEAST 24 10 MONTHS AFTER THE DATE OF THE PROCLAMATION OF FORFEITURE.

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 12 October 1, 2016.
