A BILL ENTITLED

1 AN ACT concerning

2 **Human Services – Homelessness – Emergency Cold Weather Planning**

3 FOR the purpose of establishing an emergency cold weather council in each county;
4 establishing the membership and chair of emergency cold weather councils;
5 requiring emergency cold weather councils to create certain plans; requiring a plan
6 to include certain elements; requiring local administering agencies to provide a
7 certain plan to the Department of Human Resources on or before a certain date each
8 year; requiring the Maryland Emergency Management Agency to report certain
9 information to local administering agencies under certain conditions; requiring local
10 administering agencies to initiate certain plans under certain conditions; requiring
11 certain agencies to collaborate to create a reporting system for cold weather deaths
12 of people experiencing homelessness; defining certain terms; and generally relating
13 to cold weather planning for people experiencing homelessness.

16 Section 6–441 through 6–447 to be under the new part “Part V. Emergency Cold
17 Weather Planning”

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

21 That the Laws of Maryland read as follows:

22 **Article – Human Services**

23 **6–439. RESERVED.**

2 **PART V. EMERGENCY COLD WEATHER PLANNING.**

3 **6-441.**

4 (A) IN THIS PART THE FOLLOWING WORDS HAVE THE MEANINGS
5 INDICATED.

6 (B) "CONTINUUM OF CARE" MEANS A REGIONAL OR LOCAL PLANNING BODY
7 THAT COORDINATES HOUSING AND SERVICES FUNDING FOR FAMILIES AND
8 INDIVIDUALS EXPERIENCING HOMELESSNESS.

9 (C) "GOVERNING BODY" MEANS:

10 (1) FOR BALTIMORE CITY, THE MAYOR AND CITY COUNCIL OF
11 BALTIMORE CITY;

12 (2) FOR A CHARTER COUNTY:

13 (I) THAT DOES NOT HAVE AN ELECTED CHIEF EXECUTIVE
14 OFFICER, THE COUNTY COUNCIL; OR

15 (II) THAT HAS AN ELECTED CHIEF EXECUTIVE OFFICER, THE
16 COUNTY COUNCIL OR THE COUNTY COUNCIL AND THE COUNTY EXECUTIVE, AS
17 PROVIDED BY THE COUNTY CHARTER;

18 (3) FOR A CODE COUNTY, THE COUNTY COMMISSIONERS; AND

19 (4) FOR A COMMISSION COUNTY, THE COUNTY COMMISSIONERS.

20 (D) "LOCAL ADMINISTERING AGENCY" MEANS THE AGENCY DESIGNATED BY
21 THE DEPARTMENT OR A COUNTY TO MANAGE THE HOMELESS SERVICES PROGRAM
22 FUNDED BY THE DEPARTMENT IN A COUNTY, AND TO PROVIDE SERVICES DIRECTLY
23 OR BY CONTRACT WITH A SERVICE PROVIDER.

24 (E) "WIND CHILL TEMPERATURE" MEANS THE APPARENT TEMPERATURE
25 AS MEASURED BY THE NATIONAL WEATHER SERVICE USING AIR TEMPERATURE
26 AND WIND SPEED.

28 **THERE IS AN EMERGENCY COLD WEATHER COUNCIL IN EACH COUNTY.**

1 **6-443.**

2 **AN EMERGENCY COLD WEATHER COUNCIL CONSISTS OF THE FOLLOWING**
3 **MEMBERS:**

4 **(1) A REPRESENTATIVE OF THE LOCAL ADMINISTERING AGENCY;**

5 **(2) A REPRESENTATIVE OF THE CONTINUUM OF CARE;**

6 **(3) A REPRESENTATIVE OF THE LOCAL DEPARTMENT OF SOCIAL**
7 **SERVICES;**

8 **(4) A REPRESENTATIVE OF THE LOCAL ORGANIZATION FOR**
9 **EMERGENCY MANAGEMENT;**

10 **(5) A REPRESENTATIVE OF THE LOCAL HEALTH DEPARTMENT; AND**

11 **(6) A REPRESENTATIVE OF THE GOVERNING BODY OF THE COUNTY.**

12 **6-444.**

13 **THE REPRESENTATIVE OF THE LOCAL ADMINISTERING AGENCY SHALL CHAIR**
14 **THE EMERGENCY COLD WEATHER COUNCIL IN A COUNTY.**

15 **6-445.**

16 **(A) (1) THE EMERGENCY COLD WEATHER COUNCIL SHALL WORK IN**
17 **CONSULTATION WITH LOCAL PROVIDERS, AND WITH GUIDANCE FROM THE**
18 **DEPARTMENT, TO DEVELOP AN EMERGENCY COLD WEATHER PLAN.**

19 **(2) THE EMERGENCY COLD WEATHER PLAN SHALL INCLUDE:**

20 **(I) A PLAN TO IDENTIFY, TRANSPORT, AND SHELTER PEOPLE**
21 **EXPERIENCING HOMELESSNESS IN THE COUNTY;**

22 **(II) AGENCY COMMUNICATION;**

23 **(III) THE ROLES AND RESPONSIBILITIES OF AGENCIES AND**
24 **PROVIDERS;**

25 **(IV) A FUNDING PLAN, INCLUDING:**

- 1 **1. BUDGETED COSTS; AND**
- 2 **2. FEDERAL, STATE, AND LOCAL SOURCES OF FUNDING;**
- 3 **(V) A SYSTEM FOR EVALUATING THE IMPLEMENTATION OF THE**
4 **PLAN; AND**
- 5 **(VI) IDENTIFICATION OF GAPS IN SERVICES AND FUNDING.**

6 **(B) ON OR BEFORE OCTOBER 1 EACH YEAR, THE LOCAL ADMINISTERING**
7 **AGENCY IN EACH COUNTY SHALL SUBMIT THE EMERGENCY COLD WEATHER PLAN**
8 **DEVELOPED BY THE EMERGENCY COLD WEATHER COUNCIL TO THE DEPARTMENT.**

9 **6-446.**

10 **(A) A LOCAL ADMINISTERING AGENCY SHALL INITIATE THE EMERGENCY**
11 **COLD WEATHER PLAN IF THE WIND CHILL TEMPERATURE IS AT OR BELOW 32**
12 **DEGREES FAHRENHEIT IN THAT COUNTY.**

13 **(B) THE MARYLAND EMERGENCY MANAGEMENT AGENCY SHALL REPORT**
14 **TO A LOCAL ADMINISTERING AGENCY IF THE WIND CHILL TEMPERATURE IS AT OR**
15 **BELOW 32 DEGREES FAHRENHEIT IN THE COUNTY SERVED BY THE LOCAL**
16 **ADMINISTERING AGENCY.**

18 **THE OFFICE OF THE CHIEF MEDICAL EXAMINER, THE DEPARTMENT OF**
19 **HEALTH AND MENTAL HYGIENE, AND THE DEPARTMENT OF HUMAN RESOURCES**
20 **SHALL COLLABORATE TO CREATE A REPORTING SYSTEM FOR COLD WEATHER**
21 **DEATHS OF PEOPLE EXPERIENCING HOMELESSNESS.**

22 **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect**
23 **October 1, 2016.**
