1 AN ACT concerning

2 **Service, Stipends, and Scholarships – Maryland Corps Program – Established**

3 FOR the purpose of establishing the Maryland Corps Program; providing for the purpose
4 of the Program; requiring a certain Board of Directors to administer and manage the
5 Program; providing for the composition of the Board; providing for the appointment,
6 terms, and removal of members of the Board; providing that members of the Board
7 may not receive certain compensation but are entitled to certain reimbursement;
8 requiring the Governor's Office on Service and Volunteerism within the Governor's
9 Office of Community Initiatives to provide certain staffing and assistance to the
10 Board and a certain operator; requiring the Board to submit a certain Request for
11 Proposals (RFP) on or before a certain date; requiring the RFP to include certain
12 elements and expectations for a certain operator; requiring certain corps participants
13 to serve a certain nonprofit or governmental entity for a certain period of time;
14 authorizing certain corps participants to receive certain stipends and certain
15 scholarships under certain circumstances; specifying the use of certain scholarships;
16 establishing the Maryland Corps Program Fund; specifying the purpose of the Fund;
17 requiring the Board to administer the Fund; specifying that the Fund is a continuing,
18 nonlapsing fund that is not subject to a certain provision of law; requiring the State
19 Treasurer to hold the Fund separately and invest the money in the Fund in a certain
20 manner; requiring the Comptroller to account for the Fund; providing for the
21 composition and uses of the Fund; prohibiting any unspent portion of the Fund from

39 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

40 That the Laws of Maryland read as follows:

Article – Education

18–103.

Except as otherwise provided in Subtitles 4, 5, and 12 of this title, a scholarship, grant, loan, or other student financial assistance awarded by the Office may be used only at a public or private nonprofit institution of higher education in this State that possesses a certificate of approval from the Commission.

(D) “FUND” MEANS THE MARYLAND CORPS PROGRAM FUND.

(E) “PROGRAM” MEANS THE MARYLAND CORPS PROGRAM.
