A BILL ENTITLED

1 AN ACT concerning

2 **Washington County Board of Education – Access to Public School Courses –**
3 **Nonpublic School Students**

4 FOR the purpose of requiring the Washington County Board of Education to allow a
5 nonpublic school student to enroll in up to a certain number of classes in a certain
6 public school; requiring a certain nonpublic school student to meet certain eligibility
7 requirements for public school students; requiring the State and county to reimburse
8 a certain public school a certain amount of money under certain circumstances;
9 requiring a certain nonpublic school student to be counted toward a certain county's
10 student enrollment for the purpose of calculating a certain county governing body's
11 maintenance of effort requirement in a certain manner; providing for the application
12 of this Act; defining a certain term; and generally relating to access to public school
13 courses by nonpublic school students by the Washington County Board of Education.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

21 **Article – Education**

22 **7–311.**

23 **(A) IN THIS SECTION, “NONPUBLIC SCHOOL STUDENT” MEANS AN**
24 **INDIVIDUAL WHO:**

1 **(1) IS RECEIVING REGULAR THOROUGH INSTRUCTION DURING THE**
2 **SCHOOL YEAR IN THE STUDIES USUALLY TAUGHT IN THE PUBLIC SCHOOLS TO**
3 **CHILDREN OF THE SAME AGE OR ACADEMIC LEVEL AS REQUIRED UNDER § 7-301 OF**
4 **THIS SUBTITLE; AND**

5 **(2) IS OTHERWISE ELIGIBLE TO ENROLL IN A PUBLIC SCHOOL.**

6 **(B) THIS SECTION APPLIES ONLY IN WASHINGTON COUNTY.**

7 **(C) (1) THE COUNTY BOARD SHALL ALLOW A NONPUBLIC SCHOOL**
8 **STUDENT TO ENROLL IN UP TO THREE CLASSES EACH SEMESTER IN THE PUBLIC**
9 **SCHOOL THAT THE NONPUBLIC SCHOOL STUDENT WOULD OTHERWISE BE REQUIRED**
10 **TO ATTEND.**

11 **(2) A NONPUBLIC SCHOOL STUDENT WHO ENROLLS IN PUBLIC**
12 **SCHOOL CLASSES UNDER PARAGRAPH (1) OF THIS SUBSECTION SHALL MEET ALL**
13 **ELIGIBILITY REQUIREMENTS FOR PUBLIC SCHOOL STUDENTS.**

14 **(D) (1) THE PUBLIC SCHOOL IN WHICH A NONPUBLIC SCHOOL STUDENT**
15 **ENROLLS IN ANY NUMBER OF CLASSES DURING A SCHOOL YEAR UNDER SUBSECTION**
16 **(C) OF THIS SECTION SHALL BE REIMBURSED AN AMOUNT FOR EACH NONPUBLIC**
17 **SCHOOL STUDENT THAT EQUALS THE PRODUCT OF:**

18 **(I) THE QUOTIENT OF THE TARGET PER PUPIL FOUNDATION**
19 **AMOUNT AS DEFINED IN § 5-202 OF THIS ARTICLE DIVIDED BY THE NUMBER OF**
20 **REQUIRED CLASSES FOR A FULL-TIME PUBLIC SCHOOL STUDENT DURING THE**
21 **SCHOOL YEAR; AND**

22 **(II) THE NUMBER OF CLASSES THAT A NONPUBLIC SCHOOL**
23 **STUDENT ENROLLED IN DURING THE SCHOOL YEAR.**

24 **(2) THE REIMBURSEMENT AMOUNT CALCULATED IN PARAGRAPH (1)**
25 **OF THIS SUBSECTION SHALL BE SHARED BY THE STATE AND THE COUNTY IN THE**
26 **SAME RATIO AS THE STATE AND LOCAL SHARE OF THE FOUNDATION PROGRAM FOR**
27 **THAT COUNTY AS CALCULATED IN § 5-202 OF THIS ARTICLE.**

28 **(E) A NONPUBLIC SCHOOL STUDENT WHO ENROLLS IN PUBLIC SCHOOL**
29 **CLASSES UNDER SUBSECTION (C) OF THIS SECTION SHALL BE COUNTED TOWARD A**
30 **COUNTY'S STUDENT ENROLLMENT FOR THE PURPOSE OF CALCULATING THE**
31 **COUNTY GOVERNING BODY'S MAINTENANCE OF EFFORT REQUIREMENT UNDER §**
32 **5-202(D)(1)(II) OF THIS ARTICLE, AS FOLLOWS:**

1 **(1) A STUDENT WHO ENROLLS IN ONE CLASS SHALL COUNT AS 0.17 OF**
2 **A FULL-TIME STUDENT;**

3 **(2) A STUDENT WHO ENROLLS IN TWO CLASSES SHALL COUNT AS 0.33**
4 **OF A FULL-TIME STUDENT; AND**

5 **(3) A STUDENT WHO ENROLLS IN THREE CLASSES SHALL COUNT AS**
6 **0.50 OF A FULL-TIME STUDENT.**

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
8 1, 2016.
