A BILL ENTITLED

1 AN ACT concerning

2 **Criminal Law – Impersonating a Military Member – Penalties**
3 **(Stolen Valor Act of 2016)**

4 FOR the purpose of prohibiting a person from misrepresenting oneself as a certain military
5 member or falsely holding oneself out to be a recipient of a certain military decoration
6 or medal; establishing certain penalties; and generally relating to impersonating a
7 military member.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Criminal Law**

16 **8–906.**

17 **(A) A PERSON MAY NOT KNOWINGLY AND WITH THE INTENT TO OBTAIN**
18 **MONEY, PROPERTY, OR OTHER TANGIBLE BENEFIT:**

19 **(1) MISREPRESENT ONESELF AS A MEMBER OR VETERAN OF THE**
20 **UNITED STATES ARMED FORCES OR AN ORGANIZED MILITIA; OR**

21 **(2) FALSELY HOLD ONESELF OUT TO BE A RECIPIENT OF ANY**
22 **DECORATION OR MEDAL CREATED BY FEDERAL OR STATE LAWS OR REGULATIONS**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

1 **TO HONOR THE MEMBERS OR VETERANS OF THE UNITED STATES ARMED FORCES**
2 **OR AN ORGANIZED MILITIA, INCLUDING:**

3 (I) **A CONGRESSIONAL MEDAL OF HONOR;**

4 (II) **A DISTINGUISHED SERVICE CROSS;**

5 (III) **A NAVY CROSS;**

6 (IV) **AN AIR FORCE CROSS;**

7 (V) **A SILVER STAR;**

8 (VI) **A BRONZE STAR;**

9 (VII) **A PURPLE HEART;**

10 (VIII) **A COMBAT INFANTRYMAN'S BADGE;**

11 (IX) **A COMBAT ACTION BADGE;**

12 (X) **A COMBAT MEDICAL BADGE;**

13 (XI) **A COMBAT ACTION RIBBON;**

14 (XII) **A COMBAT ACTION MEDAL;**

15 (XIII) **A SPECIAL OPERATIONS IDENTIFIER; OR**

16 (XIV) **A SPECIAL QUALIFICATION OR SKILL IDENTIFIER.**

17 (B) **A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A MISDEMEANOR**
18 **AND ON CONVICTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 1 YEAR OR A**
19 **FINE NOT EXCEEDING \$2,500 OR BOTH.**

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
21 October 1, 2016.
