## Election Law – Automatic Voter Registration

3 FOR the purpose of requiring the Motor Vehicle Administration and certain social service 4 agencies to provide electronic records of certain individuals to the State Board of  $\mathbf{5}$ Elections; requiring the electronic records to include certain information relating to 6 each individual; requiring the State Board to determine whether each individual 7 whose electronic record it receives is eligible to be registered to vote; requiring the 8 State Board to provide the electronic record of each individual who is eligible to be 9 registered to vote to the local board of elections for the county where the individual 10 resides; requiring the local board to send a notice that contains certain information 11 to each individual who is eligible to be registered to vote; requiring a local board to 12add to the statewide voter registration list the name of each individual who is eligible 13 to be registered to vote and who does not decline to register within a specified period 14 of time; requiring that an individual added to the statewide voter registration list be 15listed as not affiliated with any political party if the individual has not selected a 16political party affiliation; authorizing the State Board to adopt regulations to 17implement this Act; requiring a public institution of higher education to provide each 18 student with the opportunity to register to vote through an automatic voter 19registration system; repealing certain requirements that the Administration, certain 20social service agencies, and public institutions of higher education conduct voter 21registration activities in a certain manner; making conforming changes; defining 22certain terms; and generally relating to universal voter registration.
