BY repealing and reenacting, without amendments, Article – Health Occupations Section 4-201 and 4-202(b) Annotated Code of Maryland (2014 Replacement Volume and 2015 Supplement) BY repealing and reenacting, with amendments, Article – Health Occupations Section 4-202(a)Annotated Code of Maryland (2014 Replacement Volume and 2015 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:
