A BILL ENTITLED

1 AN ACT concerning

2 **State Lottery – Licensed Agents – Prize Payments**

3 FOR the purpose of authorizing the Director of the State Lottery and Gaming Control
4 Agency to establish by regulation the amount certain licensed agents may pay in
5 cash game prizes; making technical corrections and stylistic changes; and generally
6 relating to the authority of the State Lottery Director to establish the amount certain
7 licensed agents may pay in cash game prizes.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – State Government**

16 9–122.

17 (c) **[A] THE DIRECTOR MAY ESTABLISH BY REGULATION THE AMOUNT A**
18 licensed agent may pay in cash game prizes [of not more than \$5,000].

19 (d) (1) **(I)** In this subsection[, the words “bank” and “guardian” and
20 references to a “member” of a “minor’s family” have the meanings] **THE FOLLOWING**
21 **WORDS HAVE THE MEANINGS INDICATED.**

1 **(II) “FINANCIAL INSTITUTION” HAS THE MEANING STATED IN §**
2 **13-301 OF THE ESTATES AND TRUSTS ARTICLE.**

3 **(III) “GUARDIAN” HAS THE MEANING STATED IN § 13-101 OF**
4 **THE ESTATES AND TRUSTS ARTICLE.**

5 **(IV) “MEMBER OF THE MINOR’S FAMILY” HAS THE MEANING**
6 **stated in § 13-301 of the Estates and Trusts Article.**

7 (2) If a minor wins a prize of less than \$5,000, the Director may give a draft,
8 as provided for in rules and regulations of the Agency payable to the order of the minor, to:

9 (i) an adult member of the minor’s family; or

10 (ii) a guardian of the minor.

11 (3) If a minor wins \$5,000 or more, the Director may deposit the prize in a
12 **[bank] FINANCIAL INSTITUTION** to the credit of one of the following, as custodian for the
13 minor:

14 (i) an adult member of the minor’s family; or

15 (ii) a guardian of the minor.

16 (4) A custodian under paragraph (3) of this subsection has the same powers
17 and duties as a custodian under the Maryland Uniform Transfers to Minors Act.

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
19 October 1, 2016.
