## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Harford County – State’s Attorney – Salary**

3 FOR the purpose of altering the annual salary of the State’s Attorney of Harford County to  
4 be equal to the salary of a judge of the District Court of Maryland; repealing a certain  
5 salary adjustment method; providing that this Act does not apply to the salary or  
6 compensation of the State’s Attorney of Harford County while serving in a certain  
7 term of office; providing for the application of this Act; and generally relating to the  
8 salary of the State’s Attorney of Harford County.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
20 That the Laws of Maryland read as follows:

2 (a) This section applies only in Harford County.

3 (b) (1) The State's Attorney's ANNUAL salary is **[\$98,500] EQUAL TO THE**  
4 **SALARY OF A JUDGE OF THE DISTRICT COURT OF MARYLAND.**

5 [(2) Subject to paragraph (3) of this subsection, on or after July 1 of each  
6 year, the salary shall be adjusted using the annual Consumer Price Index that is published  
7 by the U.S. Bureau of Labor Statistics:

8 (i) for the period ending each December;

9 (ii) for all regions; and

10 (iii) to reflect the annual change in the "Consumer Price Index" for  
11 "All urban consumers" for the expenditure category "All items not seasonally adjusted".

12 (3) The annual adjustment under paragraph (2) of this subsection may not  
13 exceed 3% in a fiscal year.]

14 [(4)] (2) The county government shall pay all reasonable expenses for the  
15 conduct of the office.

16 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 35  
17 of the Maryland Constitution, this Act may not be construed to extend or apply to the salary  
18 or compensation of the State's Attorney of Harford County while serving in a term of office  
19 beginning before the effective date of this Act, but the provisions of this Act concerning the  
20 salary or compensation of the State's Attorney of Harford County shall take effect at the  
21 beginning of the next following term of office. This limitation does not apply to an individual  
22 appointed or elected after the effective date of this Act to fill out an unexpired term.

23 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
24 October 1, 2016.
