BY repealing and reenacting, with amendments, Article – Alcoholic Beverages Section 2–202 Annotated Code of Maryland (As enacted by Chapter ___ (S.B. ___)(6lr1406) of the Acts of the General Assembly of 2016) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Alcoholic Beverages 2-202.

- 1 (b) The license shall be obtained for each trade name and each distillery in the 2 State. 3 (c) A license holder may: 4 establish and operate a plant for distilling brandy, rum, whiskey, (1) alcohol, and neutral spirits at the location described in the license; 5 6 sell and deliver the alcoholic beverages: (2)7 (i) in bulk to a person in the State that is authorized to acquire 8 them; and 9 (ii) to a person outside the State that is authorized to acquire them; 10 manufacture an alcoholic beverage listed in item (1) of this subsection 11 in the name of another person or under a trade name if the other person or trade name also 12holds a Class 1 distillery license; 13 acquire alcoholic beverages in bulk from the holder of a Class 1 distillery license, Class 2 rectifying license, Class 3 winery license, or nonresident dealer's 14 15 permit; and 16 (5)(i) conduct guided tours of the licensed premises; 17 serve not more than three samples of products manufactured at (ii) 18 the licensed premises, with each sample consisting of not more than one-half ounce from a single product, to an individual who has attained the legal drinking age and participated 19 20 in a guided tour of the licensed premises; and 21[subject to subsection (d) of this section,] sell not more than three (iii) 22750-milliliter bottles of products manufactured on the licensed premises, for off-premises 23 consumption, and related merchandise to an individual who has attained the legal drinking 24age and participated in a guided tour of the licensed premises. 25A license holder may sell bottles of products under subsection (c)(5)(iii) of this 26section only if the license holder manufactures not more than 27,500 gallons of products 27 annually.
- 28 (e)] A license holder or entity in which a license holder has a pecuniary interest 29 may not act as a caterer of food.
