1 AN ACT concerning

2 **State Retirement and Pension System – Reemployment of Ordinary Disability**
3 **Retirees – Earnings Limitation**

4 FOR the purpose of exempting from a certain reemployment earnings limitation certain
5 retirees whose average final compensation was less than a certain amount and who
6 are reemployed while receiving an ordinary disability retirement allowance from the
7 State Retirement and Pension System; making stylistic changes; and generally
8 relating to the reemployment earnings limitation for ordinary disability retirees in
9 the State Retirement and Pension System.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

17 **Article – State Personnel and Pensions**

18 29–116.

19 (a) This section does not apply to a **DISABILITY** retiree [who is]:

1 (1) **(I)** **WHO IS** a retiree of:

2 ~~(i)~~ **1.** the State Police Retirement System;

3 ~~(ii)~~ **2.** the Law Enforcement Officers' Pension System;

4 ~~(iii)~~ **3.** the Local Fire and Police System; or

5 ~~(iv)~~ **4.** the Employees' Retirement System or the Employees'

6 Pension System, if at the time of retirement the retiree was a law enforcement officer for a

7 participating employer under § 26–201(a) of this article; and

8 ~~(2)~~ **(II)** **WHO IS** reemployed by a participating employer in any position

9 other than a probationary status law enforcement officer, a law enforcement officer, or

10 chief, as defined in § 3–101 of the Public Safety Article; **OR**

11 ~~(3)~~ **(2)** **(I)** **WHOSE AVERAGE FINAL COMPENSATION WAS LESS**

12 **THAN \$25,000; AND**

13 **(II)** **WHO IS REEMPLOYED BY A PARTICIPATING EMPLOYER.**

14 (b) The Board of Trustees shall reduce the pension of a retiree on ordinary

15 disability if:

16 (1) the retiree is under normal retirement age;

17 (2) the medical board certifies in a report to the Board of Trustees that the

18 retiree is employed by a participating employer at an annual compensation that is greater

19 than the difference between:

20 (i) the retiree's retirement allowance at retirement; and

21 (ii) the retiree's average final compensation plus \$5,000;

22 (3) the Board of Trustees agrees with the medical board's report; and

23 (4) the retiree's allowance has not been temporarily suspended as provided

24 in § 29–115 of this subtitle.

25 (c) The Board of Trustees shall reduce the pension of a retiree who has been

26 receiving an ordinary disability retirement allowance for:

27 (1) less than 10 years, by \$1 for every \$2 that the retiree's current

28 compensation exceeds the limit under subsection (b) of this section; or

1 (2) at least 10 years, by \$1 for every \$5 that the retiree's current
2 compensation exceeds the limit under subsection (b) of this section.

3 (d) The pension to be reduced under this section is the pension at retirement
4 without any cost-of-living adjustment.

5 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
6 1, 2016.
