- 15 (a) (1) Except as otherwise provided in this title, an individual shall be licensed by the Commission as a real estate broker before the individual may provide real 16 17 estate brokerage services in the State.
- 18 Except as otherwise provided in this title, an individual shall be 19 licensed by the Commission as an associate real estate broker or a real estate salesperson 20 before the individual, while acting on behalf of a real estate broker, may provide real estate 21 brokerage services in the State.
