2 **Alcoholic Beverages – Sale of Powdered Alcohol – Prohibition**

3 FOR the purpose of prohibiting a person from selling or offering to sell alcoholic beverages
4 that are sold in a powder or crystalline form for direct use or use in combination with
5 water or any other substance; providing a certain penalty; and generally relating to
6 a prohibition on the sale of powdered alcohol.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
21 That Section(s) 6–326, 6–327, 6–328, and 6–329, respectively, of Article – Alcoholic

3 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
4 as follows:

5 **Article – Alcoholic Beverages**

6 **6–326.**

7 **(A) A PERSON MAY NOT SELL OR OFFER FOR SALE ALCOHOLIC BEVERAGES**
8 **THAT ARE SOLD IN POWDER OR CRYSTALLINE FORM FOR DIRECT USE OR USE IN**
9 **COMBINATION WITH WATER OR ANY OTHER SUBSTANCE.**

10 **(B) (1) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A**
11 **MISDEMEANOR AND ON CONVICTION IS SUBJECT TO A FINE NOT EXCEEDING \$1,000.**

12 **(2) EACH VIOLATION OF THIS SECTION IS A SEPARATE OFFENSE.**

13 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
14 1, 2016.
