FOR the purpose of altering certain provisions of law relating to a wine festival in Calvert
County; authorizing the Board of License Commissioners for Calvert County to issue
a beer and wine festival (BWF) license to certain alcoholic beverages license holders
or a certain nonprofit organization; providing for the scope of the beer and wine
festival license; requiring the Board to choose not more than a certain number of
weekends each year for the beer and wine festival; and generally relating to the sale
of alcoholic beverages in Calvert County.
