BY repealing and reenacting, with amendments, Article – Alcoholic Beverages Section 14-1304 Annotated Code of Maryland (As enacted by Chapter ____ (S.B. ____)(6lr1406) of the Acts of the General Assembly of 2016) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND. That the Laws of Maryland read as follows: Article - Alcoholic Beverages 14-1304. (a) There is a **BEER AND** wine festival **[(WF)] (BWF)** license.
