#### A BILL ENTITLED

1 AN ACT concerning

### 2 Task Force to Study the Impact of Cell Phone Use in Public Schools

3 FOR the purpose of establishing the Task Force to Study the Impact of Cell Phone Use in 4 Public Schools; providing for the composition, chair, and staffing of the Task Force;  $\mathbf{5}$ prohibiting a member of the Task Force from receiving certain compensation, but 6 authorizing the reimbursement of certain expenses; requiring the Task Force to 7 study, assess, and consider certain matters; requiring the Task Force to report its 8 findings and recommendations to the Governor and the General Assembly on or 9 before a certain date; providing for the termination of this Act; and generally relating to the Task Force to Study the Impact of Cell Phone Use in Public Schools. 10

# SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That:

- 13 (a) There is a Task Force to Study the Impact of Cell Phone Use in Public Schools.
- 14 (b) The Task Force consists of the following members:
- (1) one member of the Senate of Maryland, appointed by the President ofthe Senate;
- 17 (2) one member of the House of Delegates, appointed by the Speaker of the18 House;
- 19 (3) one representative of the State Superintendent of Schools, or the State20 Superintendent's designee; and
- 21 (4) the following members appointed by the Governor:
- (i) a representative from the Maryland Association of Boards ofEducation;
