1 AN ACT concerning

Frederick County and St. Mary's County – Alcoholic Beverages – Art Gallery Beer and Wine License

FOR the purpose of authorizing the Board of License Commissioners for Frederick County 4 $\mathbf{5}$ and the Board of License Commissioners for St. Mary's County to issue an art gallery 6 beer and wine license to nonprofit and for-profit retail businesses that display and 7 sell original artwork or certain copies of original artwork by an individual or a group 8 of artists; prohibiting a certain type of business from being issued the license; 9 specifying that a holder of the license may sell or serve beer and wine at retail for 10 on-premises consumption when snacks are served during certain hours; specifying 11 a license fee; prohibiting the license from being transferred from the location for 12 which the license was originally issued to another location; and generally relating to 13an art gallery license in Frederick County and St. Mary's County.

4 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 5 That Section(s) 20–1001 and 28–1001, respectively, of Article – Alcoholic Beverages of the 6 Annotated Code of Maryland be renumbered to be Section(s) 20–1001.1 and 28–1001.1, 7 respectively.

12 (A) (1) THE BOARD MAY ISSUE AN ART GALLERY BEER AND WINE 13 LICENSE TO A NONPROFIT OR FOR-PROFIT RETAIL BUSINESS ENGAGED IN THE 14 DISPLAY AND SALE OF ORIGINAL ARTWORK, OR COPIES OF ORIGINAL ARTWORK 15 <u>THAT ARE REPRODUCED NO MORE THAN 300 TIMES</u>, BY AN INDIVIDUAL ARTIST OR A 16 GROUP OF ARTISTS.

17 (2) A BUSINESS THAT DISPLAYS AND SELLS COMMERCIALLY 18 PREPARED OR MASS-PRODUCED ARTISTIC PRODUCTS MAY NOT BE ISSUED THE 19 LICENSE.

(B) THE LICENSE HOLDER MAY SELL OR SERVE BEER AND WINE AT RETAIL
FOR ON-PREMISES CONSUMPTION WHEN SNACKS ARE SERVED DURING NORMAL
BUSINESS HOURS BUT NOT LATER THAN MIDNIGHT.

24(D) THE LICENSE MAY NOT BE TRANSFERRED FROM THE LOCATION FOR25WHICH THE LICENSE WAS ORIGINALLY ISSUED TO ANOTHER LOCATION.

27(A)(1)THE BOARD MAY ISSUE AN ART GALLERY BEER AND WINE28LICENSE TO A NONPROFIT OR FOR-PROFIT RETAIL BUSINESS ENGAGED IN THE29DISPLAY AND SALE OF ORIGINAL ARTWORK, OR COPIES OF ORIGINAL ARTWORK30THAT ARE REPRODUCED NO MORE THAN 300 TIMES, BY AN INDIVIDUAL ARTIST OR A31GROUP OF ARTISTS.

4 (B) THE LICENSE HOLDER MAY SELL OR SERVE BEER AND WINE AT RETAIL 5 FOR ON-PREMISES CONSUMPTION WHEN SNACKS ARE SERVED DURING NORMAL 6 BUSINESS HOURS BUT NOT LATER THAN MIDNIGHT.

7 (C) <u>THE ANNUAL LICENSE FEE IS \$100.</u>

8 (D) THE LICENSE MAY NOT BE TRANSFERRED FROM THE LOCATION FOR 9 WHICH THE LICENSE WAS ORIGINALLY ISSUED TO ANOTHER LOCATION.

10 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July 11 1, 2016.
