A BILL ENTITLED

1 AN ACT concerning

2 **Allegany County – Alcoholic Beverages – Sunday Sales for Class A Licenses**

3 FOR the purpose of authorizing a holder of a Class A beer license, a Class A beer and light
4 wine license, or a Class A beer, wine, and liquor license to sell certain alcoholic
5 beverages during certain hours under certain circumstances in Allegany County;
6 authorizing the Board of License Commissioners for Allegany County to issue a
7 certain Sunday sales permit to holders of certain licenses under certain
8 circumstances; specifying that an applicant for a certain Sunday sales permit need
9 not have certain kitchen facilities on the licensed premises; providing that a certain
10 Sunday sales permit authorizes the holder to sell certain alcoholic beverages for
11 off-premises consumption during certain hours on not more than a certain number
12 of Sundays in a year; specifying the fee for each time a certain Sunday sales permit
13 is used; and generally relating to alcoholic beverages in Allegany County.

7 1. PAYS AN ADDITIONAL FEE OF \$250; OR

8 2. IS ISSUED A 2–DAY SUNDAY SALES PERMIT IN
9 ACCORDANCE WITH PARAGRAPH (2) OF THIS SUBSECTION.

10 (2) (I) THE BOARD MAY ISSUE A 2–DAY SUNDAY SALES PERMIT TO

12 (II) AN APPLICANT FOR A 2–DAY SUNDAY SALES PERMIT NEED

14 (III) A 2–DAY SUNDAY SALES PERMIT AUTHORIZES THE HOLDER
15 TO SELL BEER AND LIGHT WINE FOR OFF–PREMISES CONSUMPTION ON NOT MORE
16 THAN TWO SUNDAYS IN A YEAR FROM 11 A.M. TO MIDNIGHT.

22 liquor for off–premises consumption:

23 (I) on Monday through Saturday from 7 a.m. to 2 a.m. the following
24 day; AND

25 (II) ON SUNDAY FROM 11 A.M. TO MIDNIGHT IF THE HOLDER:

26 1. PAYS AN ADDITIONAL FEE OF \$250; OR

27 2. IS ISSUED A 2–DAY SUNDAY SALES PERMIT IN
28 ACCORDANCE WITH PARAGRAPH (2) OF THIS SUBSECTION.

1 **(2) (I) THE BOARD MAY ISSUE A 2-DAY SUNDAY SALES PERMIT TO**

11 The Board shall determine the hours of sale for December 31 and January 1,
12 regardless of the days of the week on which those dates fall.

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
14 1, 2016.
