### A BILL ENTITLED

#### 1 AN ACT concerning

#### 2 Task Force to Examine Incentives and Funding Sources for Food Deserts

3 FOR the purpose of establishing the Task Force to Examine Incentives and Funding 4 Sources for Food Deserts; providing for the composition, chair, and staffing of the  $\mathbf{5}$ Task Force; prohibiting a member of the Task Force from receiving certain 6 compensation, but authorizing the reimbursement of certain expenses; establishing 7 the duties of the Task Force; requiring the Task Force to report its findings and 8 recommendations to the Governor and the General Assembly on or before a certain 9 date; providing for the termination of this Act; and generally relating to the Task Force to Examine Incentives and Funding Sources for Food Deserts. 10

# SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That:

- 13 (a) There is a Task Force to Examine Incentives and Funding Sources for Food14 Deserts.
- 15 (b) The Task Force consists of the following members:
- 16 (1) two members of the Senate of Maryland, appointed by the President of17 the Senate;
- 18 (2) two members of the House of Delegates, appointed by the Speaker of19 the House;
- 20 (3) the Secretary of Health and Mental Hygiene, or the Secretary's 21 designee;
- 22 (4) the Secretary of Housing and Community Development, or the 23 Secretary's designee;

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 2 1, 2016. It shall remain effective for a period of 1 year and 6 months and, at the end of 3 December 31, 2017, with no further action required by the General Assembly, this Act shall 4 be abrogated and of no further force and effect.
