A BILL ENTITLED

1 AN ACT concerning

2 **Health Care Decisions Act – End-of-Life Decision-Making Informational**
3 **Booklet**

4 FOR the purpose of requiring the Department of Health and Mental Hygiene, in
5 consultation with a certain council, to develop an end-of-life decision-making
6 informational booklet; requiring the booklet to contain certain information; requiring
7 the Department to distribute the booklet to certain health care providers, make the
8 booklet available to the public on the Department's Web site, and annually review
9 and update the booklet as necessary; requiring health care providers to provide the
10 booklet to certain patients under certain circumstances; requiring the Department
11 to distribute and make the booklet available on or before a certain date; defining a
12 certain term; and generally relating to an end-of-life decision-making informational
13 booklet.

16 Section 5-629 to be under the new part “Part III. End-of-Life Decision-Making
17 Informational Booklet”

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
21 That the Laws of Maryland read as follows:

22 **Article – Health – General**

23 **5-627. RESERVED.**

1 **PART III. END-OF-LIFE DECISION-MAKING INFORMATIONAL BOOKLET.**

2 **5-629.**

3 **(A) IN THIS SECTION, "HEALTH CARE PROVIDER" MEANS A PERSON WHO IS**
4 **LICENSED, CERTIFIED, OR OTHERWISE AUTHORIZED UNDER THE HEALTH**
5 **OCCUPATIONS ARTICLE TO PROVIDE HEALTH OR MEDICAL CARE IN THE ORDINARY**
6 **COURSE OF BUSINESS OR PRACTICE OF A PROFESSION.**

7 **(B) THE DEPARTMENT, IN CONSULTATION WITH THE STATE ADVISORY**
8 **COUNCIL ON QUALITY CARE AT THE END OF LIFE, SHALL DEVELOP AN**
9 **END-OF-LIFE DECISION-MAKING INFORMATIONAL BOOKLET.**

10 **(C) THE BOOKLET SHALL CONTAIN INFORMATION ON HEALTH CARE**
11 **OPTIONS AVAILABLE TO INDIVIDUALS WHO HAVE BEEN DIAGNOSED AS HAVING A**
12 **TERMINAL ILLNESS, INCLUDING INFORMATION ON:**

13 **(1) PALLIATIVE CARE, INCLUDING PAIN MANAGEMENT AND**
14 **TERMINAL SEDATION;**

15 **(2) HOSPICE CARE;**

16 **(3) THE USE, WITHHOLDING, AND WITHDRAWAL OF**
17 **LIFE-SUSTAINING TREATMENT; AND**

18 **(4) TO THE EXTENT AUTHORIZED BY LAW, RECEIVING AID IN DYING,**
19 **INCLUDING THE MEDICAL PRACTICE OF A PHYSICIAN PRESCRIBING MEDICATION TO**
20 **AN INDIVIDUAL THAT THE INDIVIDUAL MAY SELF-ADMINISTER TO BRING ABOUT**
21 **THE INDIVIDUAL'S DEATH.**

22 **(D) THE DEPARTMENT SHALL:**

23 **(1) DISTRIBUTE THE BOOKLET TO HEALTH CARE PROVIDERS WHO**
24 **TREAT PATIENTS WITH TERMINAL ILLNESSES;**

25 **(2) MAKE THE BOOKLET AVAILABLE TO THE PUBLIC ON THE**
26 **DEPARTMENT'S WEB SITE; AND**

27 **(3) ANNUALLY REVIEW AND UPDATE THE BOOKLET AS NECESSARY.**

28 **(E) A HEALTH CARE PROVIDER SHALL PROVIDE THE BOOKLET TO A**
29 **PATIENT WHO HAS BEEN DIAGNOSED AS HAVING A TERMINAL ILLNESS IF:**

1 **(1) THE PATIENT INQUIRES ABOUT RECEIVING AID IN DYING FROM A**
2 **PHYSICIAN AS A HEALTH CARE OPTION; AND**

3 **(2) RECEIVING AID IN DYING FROM A PHYSICIAN IS A HEALTH CARE**
4 **OPTION AUTHORIZED BY LAW.**

5 SECTION 2. AND BE IT FURTHER ENACTED, That, on or before October 1, 2017,
6 the Department of Health and Mental Hygiene shall distribute and make available the
7 booklet required under § 5-629 of the Health – General Article, as enacted by Section 1 of
8 this Act.

9 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
10 October 1, 2016.
