A BILL ENTITLED

1 AN ACT concerning

2 **Service, Stipends, and Scholarships – Maryland Corps Program – Established**

3 FOR the purpose of establishing the Maryland Corps Program; providing for the purpose
4 of the Program; requiring a certain Board of Directors to administer and manage the
5 Program; providing for the composition of the Board; providing for the appointment,
6 terms, and removal of members of the Board; providing that members of the Board
7 may not receive certain compensation but are entitled to certain reimbursement;
8 requiring the Governor's Office on Service and Volunteerism within the Governor's
9 Office of Community Initiatives to provide certain staffing and assistance to the
10 Board and a certain operator; requiring the Board to submit a certain Request for
11 Proposals (RFP) on or before a certain date; requiring the RFP to include certain
12 elements and expectations for a certain operator; requiring certain corps participants
13 to serve a certain nonprofit or governmental entity for a certain period of time;
14 authorizing certain corps participants to receive certain stipends and certain
15 scholarships under certain circumstances; specifying the use of certain scholarships;
16 establishing the Maryland Corps Program Fund; specifying the purpose of the Fund;
17 requiring the Board to administer the Fund; specifying that the Fund is a continuing,
18 nonlapsing fund that is not subject to a certain provision of law; requiring the State
19 Treasurer to hold the Fund separately and invest the money in the Fund in a certain
20 manner; requiring the Comptroller to account for the Fund; providing for the
21 composition and uses of the Fund; prohibiting any unspent portion of the Fund from
22 being transferred or used in a certain manner; requiring the Board to prepare certain
23 reports annually; authorizing the Fund to be subject to a certain audit; requiring the
24 Governor to include certain appropriations in the State budget in certain fiscal years
25 for certain purposes; requiring the Board to explore certain possibilities; requiring
26 the Board to submit certain reports to the Governor and the General Assembly in
27 accordance with certain provisions of law; providing for the staggering of the terms
28 of certain members of the Board; stating the intent of the General Assembly in
29 awarding stipends and scholarships under this Act; requiring certain members of
30 the Board to be appointed on or before a certain date; defining certain terms; and
31 generally relating to the establishment of the Maryland Corps Program.

28 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
29 That the Laws of Maryland read as follows:

32 Except as otherwise provided in Subtitles 4, 5, and 12 of this title, a scholarship,
33 grant, loan, or other student financial assistance awarded by the Office may be used only
34 at a public or private nonprofit institution of higher education in this State that possesses
35 a certificate of approval from the Commission.

10 (4) HAS NOT OBTAINED A VOCATIONAL CERTIFICATE, AN
11 ASSOCIATE’S DEGREE, OR A BACHELOR’S DEGREE FROM AN INSTITUTION OF HIGHER
12 EDUCATION.

13 (D) “FUND” MEANS THE MARYLAND CORPS PROGRAM FUND.

14 (E) “PROGRAM” MEANS THE MARYLAND CORPS PROGRAM.

16 (A) THERE IS A MARYLAND CORPS PROGRAM IN THE STATE
17 ADMINISTERED AND MANAGED BY THE BOARD.

18 (B) THE PURPOSE OF THE PROGRAM IS TO:

19 (1) PROVIDE MEANINGFUL SERVICE OPPORTUNITIES TO AT LEAST
20 100 CORPS PARTICIPANTS THAT WILL ADDRESS THE SOCIAL NEEDS OF THE
21 COMMUNITY;

22 (2) EQUIP CORPS PARTICIPANTS WITH THE SKILLS THAT WILL
23 ENABLE THEM TO SUCCESSFULLY MAKE THE TRANSITION FROM HIGH SCHOOL TO
24 AN INSTITUTION OF HIGHER EDUCATION; AND

25 (3) PROVIDE SCHOLARSHIPS TO CORPS PARTICIPANTS WHO HAVE
26 COMPLETED THE PROGRAM TO BE USED AT INSTITUTIONS OF HIGHER EDUCATION
27 TOWARD VOCATIONAL CERTIFICATES, ASSOCIATE’S DEGREES, OR BACHELOR’S
28 DEGREES.

2 (A) A BOARD OF DIRECTORS SHALL ADMINISTER AND MANAGE THE
3 PROGRAM.

4 (B) THE BOARD CONSISTS OF THE FOLLOWING MEMBERS:

- 5 (1) TWO MEMBERS APPOINTED BY THE PRESIDENT OF THE SENATE;
6 (2) TWO MEMBERS APPOINTED BY THE SPEAKER OF THE HOUSE; AND
7 (3) THREE MEMBERS APPOINTED BY THE GOVERNOR.

8 (C) IN MAKING APPOINTMENTS TO THE BOARD, THE PRESIDENT, SPEAKER,
9 AND GOVERNOR SHALL CONSIDER:

15 (D) A MEMBER OF THE BOARD:

16 (1) MAY NOT RECEIVE COMPENSATION AS A MEMBER OF THE BOARD;
17 BUT

18 (2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE
19 STANDARD STATE TRAVEL REGULATIONS, AS PROVIDED IN THE STATE BUDGET.

20 (E) (1) THE TERM OF A MEMBER OF THE BOARD IS 4 YEARS.

21 (2) THE TERMS OF THE MEMBERS ARE STAGGERED AS REQUIRED BY
22 THE TERMS PROVIDED FOR MEMBERS ON JUNE 1, 2016.

23 (3) AT THE END OF A TERM, A MEMBER CONTINUES TO SERVE UNTIL
24 A SUCCESSOR IS APPOINTED AND QUALIFIES.

25 (F) (1) A MEMBER APPOINTED BY THE PRESIDENT MAY BE REMOVED BY
26 THE PRESIDENT FOR THE REASONS STATED IN PARAGRAPH (4) OF THIS
27 SUBSECTION.

1 **(2) A MEMBER APPOINTED BY THE SPEAKER MAY BE REMOVED BY**
2 **THE SPEAKER FOR THE REASONS STATED IN PARAGRAPH (4) OF THIS SUBSECTION.**

3 **(3) A MEMBER APPOINTED BY THE GOVERNOR MAY BE REMOVED BY**
4 **THE GOVERNOR FOR THE REASONS STATED IN PARAGRAPH (4) OF THIS**
5 **SUBSECTION.**

6 **(4) A MEMBER OF THE BOARD MAY BE REMOVED FOR:**

7 **(I) INCOMPETENCE;**

8 **(II) MISCONDUCT;**

9 **(III) IMMORALITY; OR**

10 **(IV) FAILURE TO PERFORM THE DUTIES OF THE POSITION.**

3 **(3) IDENTIFYING ACADEMIC CREDIT OPPORTUNITIES FOR CORPS**
4 **PARTICIPANTS;**

5 **(4) CREATING A SELECTIVE RECRUITMENT PROCESS FOR CORPS**
6 **PARTICIPANTS, GIVING PRIORITY TO LOW-INCOME INDIVIDUALS;**

7 **(5) CREATING AND IMPLEMENTING AN ORIENTATION AND TRAINING**
8 **PROGRAM FOR CORPS PARTICIPANTS AND THE NONPROFIT OR GOVERNMENT**
9 **AGENCIES WHERE CORPS PARTICIPANTS EFFECTUATE THEIR SERVICE;**

10 **(6) PROVIDING SUPPORT TO CORPS PARTICIPANTS IN FINDING**
11 **PLACEMENTS;**

12 **(7) EMPHASIZING AND ENCOURAGING THE IMPORTANCE OF BEING A**
13 **SUCCESSFUL CONTRIBUTOR TO SOCIETY, A MEASURE OF WHICH IS A VOCATIONAL**
14 **CERTIFICATE, AN ASSOCIATE'S DEGREE, OR A BACHELOR'S DEGREE;**

15 **(8) CREATING TOOLS TO MEASURE THE SUCCESS OF CORPS**
16 **PARTICIPANTS AS THEY TRANSITION FROM HIGH SCHOOL TO AN INSTITUTION OF**
17 **HIGHER EDUCATION FOR A VOCATIONAL CERTIFICATE, AN ASSOCIATE'S DEGREE, OR**
18 **A BACHELOR'S DEGREE;**

19 **(9) FACILITATING THE AWARD OF STIPENDS FOR CORPS**
20 **PARTICIPANTS DURING THEIR YEAR OF SERVICE;**

21 **(10) FACILITATING THE AWARD OF SCHOLARSHIPS FOR CORPS**
22 **PARTICIPANTS WHO COMPLETE THE PROGRAM TO BE USED AT INSTITUTIONS OF**
23 **HIGHER EDUCATION TOWARD VOCATIONAL CERTIFICATES, ASSOCIATE'S DEGREES,**
24 **OR BACHELOR'S DEGREES; AND**

25 **(11) ANY OTHER CHARACTERISTICS THAT THE BOARD DETERMINES**
26 **WILL IMPROVE THE QUALITY AND SUCCESS OF THE PROGRAM.**

2 **TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.**

3 **(E) (1) THE STATE TREASURER SHALL HOLD THE FUND SEPARATELY**
4 **AND SHALL INVEST THE MONEY IN THE FUND IN THE SAME MANNER AS OTHER**
5 **STATE MONEY MAY BE INVESTED.**

6 **(2) ANY INVESTMENT EARNINGS OF THE FUND SHALL BE CREDITED**
7 **TO THE FUND.**

8 **(F) THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.**

9 **(G) THE BOARD:**

10 **(1) MAY ACCEPT ANY GIFT OR GRANT FROM ANY PERSON FOR THE**
11 **FUND;**

12 **(2) SHALL USE ANY GIFT OR GRANT THAT IT RECEIVES FOR THE**
13 **REASONS STATED UNDER SUBSECTION (B) OF THIS SECTION; AND**

14 **(3) SHALL DEPOSIT ANY GIFT OR GRANT THAT IT RECEIVES FOR THE**
15 **FUND WITH THE STATE TREASURER.**

16 **(H) THE FUND CONSISTS OF:**

17 **(1) MONEY APPROPRIATED UNDER § 24-1109 OF THIS SUBTITLE;**

18 **(2) GIFTS OR GRANTS RECEIVED BY THE BOARD FOR THE FUND;**

19 **(3) INVESTMENT EARNINGS OF THE FUND; AND**

20 **(4) ANY OTHER MONEY FROM ANY OTHER SOURCE ACCEPTED FOR**
21 **THE BENEFIT OF THE FUND.**

22 **(I) THE FUND MAY BE USED ONLY FOR:**

23 **(1) PROVIDING STIPENDS TO CORPS PARTICIPANTS;**

24 **(2) PROVIDING SCHOLARSHIPS TO CORPS PARTICIPANTS WHO HAVE**
25 **COMPLETED THE PROGRAM TO BE USED AT INSTITUTIONS OF HIGHER EDUCATION**
26 **IN THE STATE TOWARD VOCATIONAL CERTIFICATES, ASSOCIATE'S DEGREES, AND**
27 **BACHELOR'S DEGREES;**

1 **(3) COVERING EXPENSES INCURRED BY THE BOARD, INCLUDING**
2 **EXPENSES INCURRED DURING THE DEVELOPMENT, ISSUANCE, AWARDING, AND**
3 **FUNDING OF THE RFP; AND**

4 **(4) COVERING EXPENSES INCURRED BY THE OPERATOR SELECTED**
5 **UNDER § 24-1105 OF THIS SUBTITLE, AS DETERMINED BY THE BOARD TO BE**
6 **RELEVANT TO THE SUCCESSFUL OPERATION OF THE PROGRAM.**

7 **(J) ANY UNSPENT PORTION OF THE FUND MAY NOT BE TRANSFERRED OR**
8 **REVERT TO THE GENERAL FUND OF THE STATE BUT SHALL REMAIN IN THE FUND**
9 **TO BE USED FOR THE PURPOSES SPECIFIED IN THIS SUBTITLE.**

10 **(K) (1) BEGINNING WITH FISCAL YEAR 2018, AT THE END OF THE FISCAL**
11 **YEAR, THE BOARD SHALL PREPARE AN ANNUAL REPORT OF THE FUND THAT**
12 **INCLUDES AN ACCOUNTING OF ALL FINANCIAL RECEIPTS AND EXPENDITURES TO**
13 **AND FROM THE FUND.**

14 **(2) THE BOARD SHALL SUBMIT A COPY OF THE REPORT TO THE**
15 **GENERAL ASSEMBLY IN ACCORDANCE WITH § 2-1246 OF THE STATE GOVERNMENT**

32 **STATE BUDGET FOR THE FUND FOR THE BOARD TO:**

2 **(2) PROVIDE SCHOLARSHIPS TO CORPS PARTICIPANTS WHO HAVE**

17 SECTION 2. AND BE IT FURTHER ENACTED, That the terms of the initial
18 members of the Board of Directors of the Maryland Corps Program established under
19 Section 1 of this Act shall expire as follows:

20 (1) two members in 2019;

21 (2) three members in 2020; and

22 (3) two members in 2021.

23 SECTION 3. AND BE IT FURTHER ENACTED, That it is the intent of the General
24 Assembly that:

25 (1) the first Maryland Corps Program stipends shall be awarded on or
26 before June 1, 2018; and

27 (2) the first Maryland Corps Program scholarships shall be awarded on or
28 before June 1, 2019.

29 SECTION 4. AND BE IT FURTHER ENACTED, That the members of the Board of
30 Directors of the Maryland Corps Program as established under Section 1 of this Act shall

1 be appointed by the President of the Senate, the Speaker of the House, and the Governor
2 on or before September 1, 2016.

3 SECTION 5. AND BE IT FURTHER ENACTED, That this Act shall take effect June
4 1, 2016.
