A BILL ENTITLED

1 AN ACT concerning

2 Harford County – Alcoholic Beverages – Community College License

3 FOR the purpose of establishing a Class CC (community college) beer and wine license in 4 Harford County; authorizing the Board of License Commissioners to issue the license $\mathbf{5}$ to an officer of a community college for use on certain parts of the community college 6 campus; providing that the license authorizes the sale of beer and wine for 7 on-premises consumption to individuals who attend certain public events and to 8 members of certain groups and their guests who attend events held for those groups; 9 prohibiting a license holder from selling beer and wine at certain events; prohibiting a license holder from allowing alcoholic beverages to be consumed during a certain 1011 time; prohibiting, with a certain exception, a license holder from allowing an 12individual to carry alcoholic beverages on to or from the licensed premises; providing 13 for an annual license fee; and generally relating to alcoholic beverages licenses in 14Harford County.

25 26 27	(E) AFTER AN EVENT IS OVER, THE LICENSE HOLDER MAY NOT ALLOW ALCOHOLIC BEVERAGES TO BE CONSUMED ON THE LICENSED PREMISES FROM MIDNIGHT TO NOON THE FOLLOWING DAY.

1 (F) A LICENSE HOLDER MAY NOT ALLOW AN INDIVIDUAL TO CARRY 2 ALCOHOLIC BEVERAGES ON TO OR FROM THE LICENSED PREMISES, EXCEPT A 3 WHOLESALER OF BEER OR WINE WHO CONDUCTS BUSINESS REGARDING AN EVENT 4 FOR WHICH A LICENSE HAS BEEN ISSUED UNDER THIS SECTION.

- 5 (G) THE ANNUAL LICENSE FEE IS \$1,500.
- 6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 7 1, 2016.
